It is instructive to read their board of advisors, which include several researchers like Louis West, of UCLA, who have worked on subsidies for the CIA. West, who still denies his past CIA connections, once tried to start a center for the study of violence at UCLA. This center, squashed by activists, would have done psychosurgery on patients, which is the melting of brain connections, for the supposed purpose of "curing violent behavior."

It is clear that some therapists do, in fact, lead patients

into making up memories of early abuse. However, some are
not all. The existence of some sham does not preclude the

THEY WANT TO KNOW

Today I spoke with a man who is very focused and extremely intelligent. He is obviously competent in his field of work. He told me he was the subject of CIA mind control experiments when he was a child.

This program, he said, was wide-ranging. There were at least two levels, two echelons. In the mid 1950s, children were brought to the United States from Mexico and South America. They were considered expendable by the CIA. The CIA performed horrendous experiments on them. Then, lessons about what worked in brainwashing were applied to other children, the "best and brightest" in America, carefully selected.

It was as if CIA experimenters hoped to establish long-term control over the minds of a budding American elite, so that, later on, top positions in American business, politics and even science would be pawns of the Agency.

Initially, the idea was to create in a child a blank slate, tabula rasa. As a follow-up, the CIA hoped to imprint enough suggestions to remake a personality wholecloth.

It appears that CIA mind control was an extension of World War II against America, from the inside. But most of the Nazis were Americans.

Some children were forced to become sex agents. They were used in straight-out blackmail schemes, involving businessmen, politicians, educators, and other bigwigs in American society. The blackmail consisted of filmed sex. Certain CIA training centers got out of hand and became sex rings. The inner-core CIA people began filming each other to obtain potential blackmail evidence, to assure silence, to protect themselves from blackmail.

In part of its operation, the CIA sought out children who were already abused, and those who would not be missed if they disappeared. Cults and extant sex rings were contacted for this purpose.

The methods of trying to make a blank slate and inducing new personalities in children included hallucinogenic drugs, electroshock, torture, dire threats, isolation, extreme disorientation, and murder of companions.

Mind control was sanctioned under the 150 sub-projects of the CIA program called MK-ULTRA. It officially lasted 10 years, circa 1952 to 1962. After that point, another group, ORD (Office of Research and Development) took over the job.

According to John Marks, author of Search for the Manchurian Candidate, the CIA has 130 boxes of files from ORD days. The Agency refuses to release them.

shooting all over Oklahoma City you would have to set 20 detonator caps timed to the same instant for all the plastic containers--not one burning fuse and one cap. But the government is just too busy to discover this fact, as they are too busy to discover so many facts that the people are aware of somehow. And big government wants us to believe, to accept its version of reality. And they want to know why we are angry.

They want to know why we despise the war on drugs, when all that is happening is that the CIA has been seeing to it that heroin and cocaine reach America's shores by the kiloton. They fight a war on drugs and they lose that war in the same intentional breath and they charge the taxpayer for it, and they use the war as a pretext to beef up police and go after innocent citizens and take their property, and they want to know why Americans are angry. they must think we don't know what they're doing.

They want to know why less people every month look to government as the beneficent solver of problems. Why more people are believing that corruption has attacked the governmental body in profusion. They want to know why their assurances no longer carry weight.

Have we ever seen a President who talks with less credibility on his person than William Clinton? Never mind which Party he belongs to. Have we ever seen so many people in minority groups, who would ordinarily look to big government as

an ally, turn their heads away in sheer disgust?

The government is puzzled at the sentiment of the American people.

Yet there are so many reasons for this sentiment, how can they all be named? The release of plutonium out of the government Los Alamos Labs in New Mexico, and the attendant rising cancer rates. Names of researchers like Bertel, Gould, Bross, Sternglass, Caldicott, who have concluded that low-level radiation is indeed very harmful to health, despite protestations to the contrary at the federal Pentagon and the federal National Cancer Institute. Indeed, Dr. Irwin Bross, formerly head of Biostatistics at Roswell Park Memorial Cancer Institute in Buffalo, from deep within the orthodox cancer research establishment, has sounded an astonishing warning that, for a decade or more, animal studies on cancer at NCI have been intentionally faked, to convey the impression that low-level radiation is safe. Bross states, on the record, that the Pentagon, fearing exposure by the blowing of the whistle by medical researchers at NCI, literally took over that institution, appointing a new head, Dr. Arthur Upton, a radiologist from Oak Ridge Labs in Tennessee. Stacking peer-review panels with like-minded radiologists, Upton stifled attempts by researchers to uncover cancers caused by low-level radiation.

And the President wants to know why American faith in the government has plummeted. He wants to know.

The American people have seen through the ploy of presenting scandals and atrocities as occasional flareups in an otherwise calm sea. The truth is the opposite. The American people know this.

I am here to talk about a possible link between radiation and mind control experimentation that began in the late 1940's. The main reason that mind control research is being mentioned is because people are alleging that they were exposed, as children, to mind control, radiation, drugs and chemical experimentation which were administered by the same doctors who are known to have been involved in conducting both radiation and mind control research. Written documentation has been provided revealing the names of people and the names of the research projects in statements from people across the country. It is also important to understand that mind control techniques and follow ups into adulthood may have been used to intimidate these particular research subjects into not

talking about their victimization in government research.

As a therapist for the past 22 years, I have specialized in treating victims and perpetrators of trauma and their families. When word got out that I was appearing at this hearing, nearly 40 therapists across the country contacted me to talk about clients who had reported being subjects in radiation and mind control experiments. The consistency of people's stories about the purpose of the mind control and pain induction techniques such as electric shock, use of hallucinogens, sensory deprivation, hypnosis, dislocation of limbs and sexual abuse is remarkable. There is almost nothing published on this aspect of mind control used with children and these clients come from all over the country, having had no contact with each other.

What was startling was that therapists reported many of these clients were also physically ill with autoimmune problems, thyroid

problems, multiple sclerosis and other muscle and connective tissue diseases as well as mysterious ailments for which a diagnosis cannot be found. While Somatization Disorder is commonly found in these clients, many of the clients who have been involved in the human experimentation with the government have multiple medically documented physical ailments. It is unclear if these physical disorders and symptoms were caused by radiation or drugs used in the experiments. Many people are afraid to tell their doctors their histories as mind control subjects for fear of being considered to be crazy.

These clients have named some of the same people, particularly a Dr. Greene, who was associated with clients' reports of childhood induction of pain, mind control techniques and childhood sexual abuse. One of my clients, who had seen him with a name tag, identified him as Dr. L. Wilson Greene. A person with this same name was the Scientific Director of the Chemical and Radiological Laboratories at the Army Chemical Center and that he was engaged in

doing research for the Army and other intelligence agencies. Other names that have come to light are Dr. Sidney Gottlieb and Dr. Martin Orne, who, it is reported were also involved in radiation research.

It needs to be made clear that people have remembered these names and events spontaneously with free recall and without the use of any memory retrieval techniques such as hypnosis. As much as possible, we have tried to verify the memories with family members, records and experts in the field. Many attempts have been made through Freedom of Information Act filings to gain access to the mind control research documentation. These requests have generally been slowed down or denied, although some information has been obtained which suggests that at least some of the information supplied by these clients is true. It is important that we obtain all of the information contained in the CIA and military files to verify or deny our clients' memories.

Although many of the files for MKULTRA may have been destroyed, whatever is left along with the files for other projects such as BLUEBIRD and ARTICHOKE contain valuable information,

Furthermore, if, as the evidence suggests, some of these people were used in radiation experiments, there might be information in the mind control experiment files on radiation experiments. If there are radiation files within the mind control files, then people across the country may then possibly have the documentation to take to their doctors to assist in their medical treatment. We need this information to help in the rehabilitation and treatment of many people who have severe psychological and medical problems which interfere with their social, emotional, and financial well being.

Finally, I urge you to recommend an investigation into these matters. Although there was a commission on mind control, it did not include experiments on children because most of them were too

young or still involved in the research in the late 1970's to come forward.

The only way to end the harassment and suffering of these people is to make public what has happened to them in the mind control experiments. Please recommend that there be an investigation on the Mind Control experiments as they related to children.

My name is Valerie Wolf. I am here to talk about a possible link between radiation and mind control experimentation that began in the late 1940's. The main reason that mind control research is being mentioned is because people are alleging that they were exposed to mind control, radiation, drugs and chemical experimentation which were administered by the same doctors who are known to have been involved in conducting radiation and mind control research. Because these people were children and were easily controlled, they appear to have been used in more than one research project. I have provided written documentation revealing the names of people involved in the research and the names of the

research projects, with statements from people across the country who allege that mind control and radiation research was conducted on well children. It is also important to understand that mind control techniques and follow ups into adulthood may have been used to intimidate these particular research subjects into not talking about their victimization in government research.

As a clinical social worker for the past 22 years, I have specialized in treating victims and perpetrators of trauma and their families. This population has included victims of disasters, Vietnam veterans and sexual, physical and emotional abuse.

In preparation for my testimony at these hearings, I called nearly 40 therapists across the country to find out what they knew about the link between radiation and mind control and to get a sense of what other therapists were seeing in clients who had been used in mind control experiments.

In the January 24, 1994 issue of U.S. News and World Report, there is an article on "The Cold War Experiments". The basic conclusion of the article is that "radiation tests were only one small part of a vast research program that used thousands of Americans as guinea pigs". The research programs included radiation, drugs, mind control and chemicals. My clients and others have reported all of these as being used on them, although technically they were considered to be part of the mind control experiments.

Generally, it appears that therapists across the country are finding clients who have been subjected to mind control techniques. The consistency of their stories about the purpose of the mind control and torture techniques such as electric shock, use of hallucinogens, sensory deprivation, spinning, hypnosis, dislocation of limbs and sexual abuse is remarkable. There is almost nothing published on this aspect of mind control used with children and these clients come from all over the country, having had no contact with each other. From the small sample of therapists to whom I

talked, it appears that about 25% of the clients report memories of being used in radiation experiments. It is possible that more people were exposed to radiation, but that the memories have not yet emerged because our awareness of this experimentation is so new.

What was startling was that therapists reported many of these clients were also physically ill with multiple sclerosis and other muscle and connective tissue diseases as well as mysterious ailments for which a diagnosis cannot be found. While Somatic Disorder is commonly found in these clients, many of the clients who have been involved in the human experimentation with the government have multiple medically documented physical ailments. It is unclear if these physical disorders and symptoms were caused by radiation or drugs used in the experiments.


→ I have a client, who appears to be typical of these clients, who has a myriad of symptoms which her doctors cannot diagnose. She



has autoimmune problems, problems with healing, thyroid problems that just appeared for no apparent reason, weight gain, edema, constant low grade fever and generally does not feel well. She has three sisters who also have mysterious ailments, including one sister who has a rare adrenal cancer. She has been asked several times by different doctors if she could have been exposed to radiation, but she does not remember. A major part of the mind control experimentation was involved in wiping out the memory of the subject through electric shock, trauma and drugs. She is afraid to tell her doctors about her history as a mind control subject for fear that they will think she is crazy.

These clients have named the same people, particularly a Dr. Greene. I had heard Dr. Greene's name for several years associated with clients' reports of childhood torture, mind control techniques and childhood sexual abuse. One of my clients, who had seen him with a name tag, identified him as Dr. L. Wilson Greene. I made inquiries and to my surprise found out that a person with this same

name was the Scientific Director of the Chemical and Radiological Laboratories at the Army Chemical Center and that he was engaged in doing research for the Army and the CIA.



It needs to be made clear that these clients have remembered these names and events spontaneously with free recall and without the use of any memory retrieval techniques such as hypnosis. As much as possible, we have tried to verify the memories. I have sent information from one of my clients to Alan Schefflin, Professor of Law at Santa Clara University Law School. He has been able to confirm that the information that she has supplied is absolutely true and that her memories could not have been derived from any published source. This client simply came into my office one day with MKULTRA written on a piece of paper after about 9 months of therapy. Another client's memories about the CIA connection to Dr. Greene appeared spontaneously several months ago. She has memories of being exposed to radiation. I had never mentioned anything about government research or the CIA to either of them prior to the

time that their memories emerged spontaneously.

With the proper knowledge of mind control techniques, these clients can be helped. I have been amazed at the progress these clients have made since I began understanding about how the mind control techniques work. Many attempts have been made through Freedom of Information Act filings to gain access to the mind control research documentation. These requests have generally been slowed down or denied, although some information has been obtained. It is very important that we have information to confirm or deny the things that are being remembered.

Furthermore, if, as the evidence suggests, some of these people were used in radiation experiments, there might be information in the mind control experiment files on radiation experiments, especially since Dr. L. Wilson Greene, Dr. Sidney Gottlieb, and Dr. Martin Orne among others, have been reported by people to have been associated with both. If there are radiation files within the mind

control files, then people across the country may then possibly have the documentation to take to their doctors to assist in their medical treatment.



There is some suggestion that this research is continuing to the present day and people and their therapists are being harassed by associates of the mind control projects who were assigned to monitor the subjects so that they never talk and so that they can continue to be used as needed.

Finally, I urge you to recommend an investigation into these matters. Although there was a commission on mind control, it did not include the children because most of them were too young or still involved in the research in the late 1970's to come forward.

The only way to end the harassment and suffering of these people is to make public what has happened to them in the mind control experiments. Please recommend that there be an investigation on

BETWEEN THE YEARS OF 1957 AND 1984, I BECAME A PAWN IN A GOVERNMENT SCHEME , WHOSE ULTIMATE GOAL WAS MIND CONTROL AND TO CREATE THE "PERFECT SPY". ALL THROUGH THE USE OF: CHEMICALS, RADIATION, DRUGS, HYPNOSIS, ELECTRIC SHOCK, ISOLATION IN TUBS OF WATER; SLEEP DEPRIVATION; BRAINWASHING AND VERBAL, PHYSICAL, EMOTIONAL & SEXUAL ABUSE. .

I WAS EXPLOITED UNWITTINGLY FOR NEARLY THREE DECADES OF MY LIFE AND THE ONLY EXPLANATIONS GIVEN TO ME WERE: "THAT THE END JUSTIFIES THE MEANS " AND "I WAS SERVING MY COUNTRY IN THEIR BOLD EFFORT TO FIGHT

COMMUNISM ".

I CAN ONLY SUMMARIZE MY CIRCUMSTANCES BY SAYING, THEY TOOK AN ALREADY ABUSED 7 YEAR OLD CHILD AND COMPOUNDED MY SUFFERING BEYOND BELIEF. THE SADDEST PART IS- I KNOW FOR A FACT; THAT I WAS NOT ALONE! THERE WERE COUNTLESS OTHER CHILDREN IN MY SAME SITUATION AND THERE WAS NO ONE TO HELP US.....UNTIL NOW.

I HAVE ALREADY SUBMITTED AS MUCH INFORMATION AS POSSIBLE; INCLUDING CONVERSATIONS OVERHEARD OF THE PEOPLE AND AGENCIES RESPONSIBLE. I AM ABLE TO REPORT THIS TO YOU IN SUCH GRAPHIC DETAIL; BECAUSE OF BOTH MY PHOTOGRAPHIC MEMORY AND THE ARROGANCE OF THE DOCTORS INVOLVED ,WHO WERE CERTAIN THEY WOULD ALWAYS CONTROL MY MIND AND BEHAVIOR. ALTHOUGH, THE PROCESS OF RECALLING THESE ATROCITIES IS


CERTAINLY NOT AN EASY TASK; NOR IS IT WITHOUT SOME DANGER TO MY SELF AND MY FAMILY. BUT , I FEEL THE RISK IS WORTH TAKING.)

DR. L. WILSON GREENE, WHO CLAIMED TO HAVE RECEIVED 50 MILLION DOLLARS FOR HIS ARMY CHEMICAL AND RADIOLOGICAL CORPORATION, AS PART OF THE TSD(TECHNICAL SCIENCE DIVISION) OF THE CIA, ONCE DESCRIBED TO A DR. CHARLES L. BROWN JR. ; "THAT CHILDREN WERE USED AS SUBJECTS BECAUSE THEY WERE MORE FUN TO WORK WITH AND CHEAPER TOO. THEY NEEDED LOWER PROFILE SUBJECTS THAN SOLDIERS OR GOVERNMENT PEOPLE, SO ONLY YOUNG WILLING FEMALES WILL DO....BESIDES ", HE SAID, " LIKE SCARING THEM...THEY AND THE AGENCY THINK I'M A GOD...CREATING SUBJECTS AND EXPERIMENTS FOR WHATEVER DEVIANT PURPOSES SID(DR.SIDNEY GOTTLIEB) AND JAMES(DR. IN 1958, I WAS TO BE TESTED THEY TOLD ME BY SOME IMPORTANT DOCTORS COMING FROM A PLACE CALLED THE "SOCIETY" (THE HUMAN ECOLOGY SOCIETY) I WAS TOLD TO COOPERATE ; ANSWER ANY OF THEIR QUESTIONS. THEN, SINCE THE TEST "MIGHT HURT, I WOULD BE GIVEN SHOTS, X-RAYS AND A FEW JOLTS OF ELECTRICITY ". I WAS ALSO INSTRUCTED, " NOT TO LOOK AT ANYONES FACE TOO HARD AND TO IGNORE NAMES,AS THIS WAS A VERY S E C R E T PROJECT,BUT TO BE BRAVE AND ALL THOSE THINGS WOULD HELP ME FORGET ". NATURALLY, AS MOST CHILDREN DO, I DID THE OPPOSITE ; AND REMEMBERED AS MUCH AS I COULD !

A DR. JOHN GITTINGER TESTED ME AND DR. CAMERON GAVE ME THE SHOCKS AND DR. GREENE THE XRAYs. THEN, I WAS TOLD BY SID (GOTTLIEB) "I WAS RIPE FOR THE BIG A- MEANING ARTICHOKE,.. "

BY THE TIME I LEFT TO GO HOME- JUST LIKE EVERY TIME FROM THEN ON, I WOULD RECALL NOTHING OF MY TESTS OR THE DIFFERENT DOCTORS. I WOULD ONLY REMEMBER WHATEVER EXPLANATIONS- DR. ROBERT G. HEATH (OF TULANE MEDICAL

SCHOOL)GAVE ME FOR THE ODD BRUISES, NEEDLE MARKS , BURNS ON MY HEAD AND FINGERS AND EVEN THE GENITAL SORENESS. I HAD NO REASON TO BELIEVE OTHERWISE. ALREADY, THEY HAD BEGUN TO CONTROL MY MIND!

THE NEXT YEAR, I WAS SENT TO A PLACE IN MARYLAND CALLED DEEP CREEK CABINS TO LEARN HOW "TO SEXUALLY PLEASE MEN". ALSO, I WAS TAUGHT HOW TO COERCE THEM INTO TALKING ABOUT THEMSELVES . IT WAS RICHARD HELMS(DEPUTY DIRECTOR OF THE CIA), DR.GOTTLIEB, CAPTAIN GEORGE WHITE AND MORSE ALLEN, WHO ALL PLANNED ON FILMING AS MANY HIGH GOVERNMENT AND AGENCY OFFICIALS AND HEADS OF ACADEMIC INSTITUTIONS AND FOUNDATIONS ,AS POSSIBLE-; SO LATER, WHEN THE FUNDING FOR MIND CONTROL AND RADIATION STARTED TO DWINDLE : THEN THE PROJECTS WOULD CONTINUE- AT ANY COST! ONCE, A CRUDE REMARK WAS MADE BY DR. GOTTLIEB ABOUT A POSSIBLE LEAK OVER IN NEW ORLEANS EAST, INVOLVING A LARGE GROUP OF RETARDED CHILDREN, WHO WERE BEING GIVEN MASSIVE DOSES OF RADIATION. HE ASKED " WHY WILSON WAS SO WORRIED ABOUT A FEW RETARDED KIDS? AFTER ALL, THEY WOULD BE THE LEAST LIKELY TO SPILL THE BEANS!"

ANOTHER TIME, I HEARD DR. MARTIN ORNE, WHO WAS THE "DIRECTOR OF THE SCIENTIFIC OFFICE" AND LATER THE INSTITUTE FOR EXPERIMENTAL RESEARCH, STATE, THAT (IN ORDER TO KEEP MORE FUNDING COMING FROM DIFFERENT SOURCES FOR THE RADIATION AND MIND CONTROL PROJECTS, HE SUGGESTED

"STEPPING UP THE AMOUNTS OF ALL THE "STRESSORS USED "AND ALSO, THE BLACKMAIL PORTION OF THE EXPERIMENTS. HE SAID, " IT NEEDED TO BE DONE FASTER , THEN GET RID OF THE SUBJECTS, AS IT WAS ASKING FOR ' US' TO COME BACK AND HAUNT THEM, BY REMEMEBRING."

THERE IS MUCH MORE I COULD TELL YOU ABOUT GOVERNMENT SPONSORED RESEARCH, INCLUDING PROJECT NAMES; SUBPROJECT NUMBERS AND THE PEOPLE INVOLVED; THE FACILITIES USED; HUMILIATING TESTS & OTHER FORMS OF TORTURE AND ABUSE; BUT , I THINK I HAVE GIVEN MORE THAN ENOUGH INFORMATION TO RECOMMEND FURTHER INVESTIGATION OF ALL MIND CONTROL PROJECTS...- ESPECIALLY AS THEY INVOLVE SO MUCH USE OF RADIATION.

I WOULD LOVE NOTHING MORE THAN TO SAY I HAD DREAMED ALL THIS UP;

AND NEED TO JUST 'FORGET IT....BUT THAT WOULD BE A TRAGIC MISTAKE! NOT ONLY THAT - IT WOULD BE A LIE. ALL THESE ATROCITIES DID OCCUR TO ME AND COUNTLESS OTHER CHILDREN; AND ALL UNDER THE GUISE OF "DEFENDING OUR COUNTRY"!

IT IS BECAUSE OF THE CUMMULATIVE EFFECT OF EXPOSURE TO THE RADIATION , CHEMICALS, DRUGS, TORTURE AND SUBSEQUENT MENTAL & PHYSICAL DISTRESS; THAT I HAVE BEEN ROBBED OF THE ABILITY TO WORK AND EVEN TO BEAR CHILDREN OF MY OWN! IT IS BLATANTLY OBVIOUS THAT NONE OF THIS WAS NEEDED- NOR SHOULD HAVE EVER BEEN ALLOWED TO TAKE PLACE AT ALL !

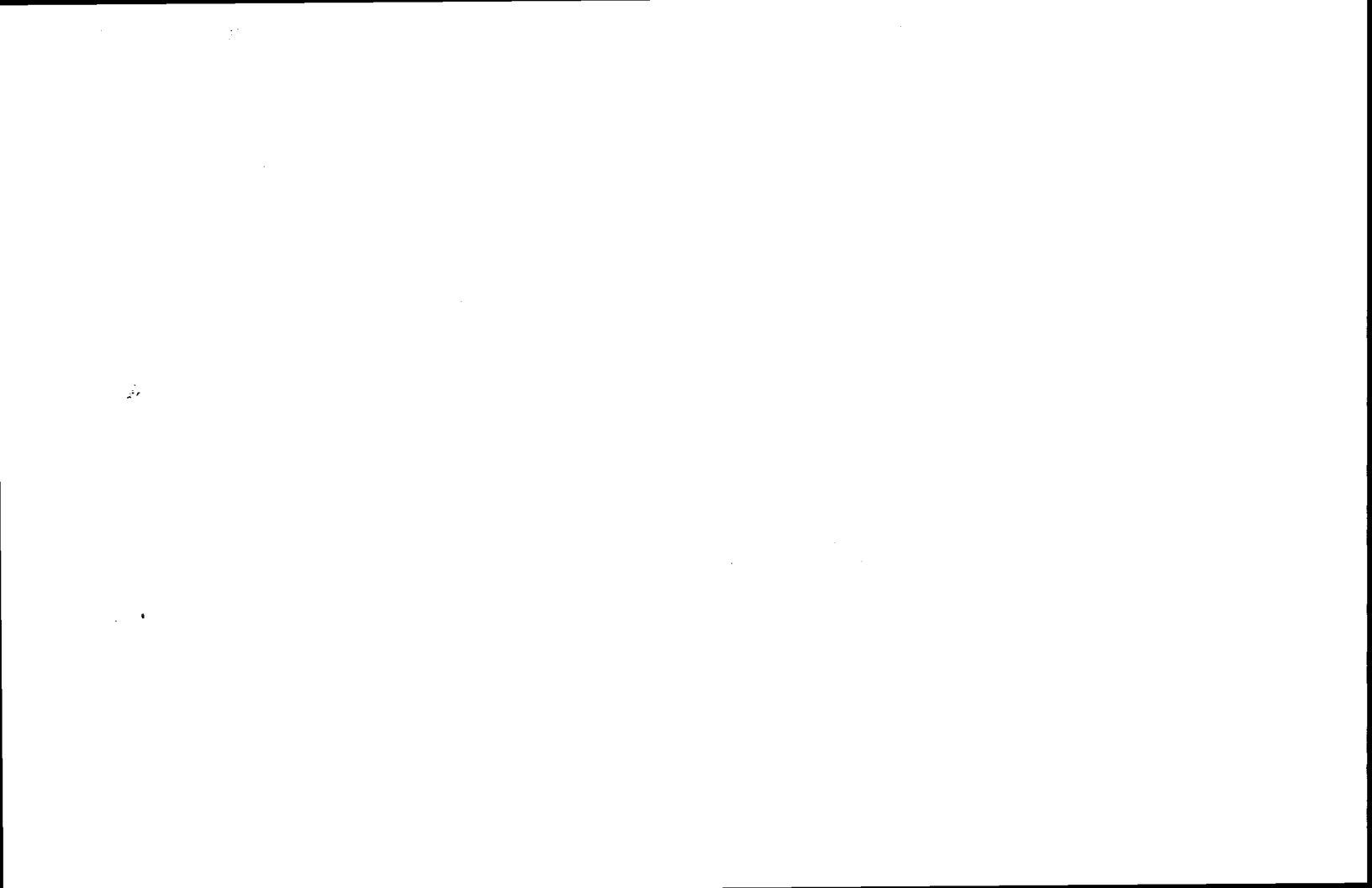

As Claudia S. Mullen's therapist, I would like to document her memory recovery process. She was referred to me after being sexually assaulted, but did not respond to treatment initially. She was constantly remembering being abused and became dysfunctional and suicidal. After about 9 months of therapy, she came to therapy one day with MKULTRA written with other words on a piece of paper. From that point on, she began to work on the mind control issues and began to improve. All of her memories have emerged spontaneously without the use of memory enhancement techniques such as hypnosis or sodium amytal. I had told her nothing about government and CIA research projects.

To the best of my knowledge, she has read nothing about mind control or CIA covert operations. Since she decided to listen carefully and remember as much as she could about conversations among the researchers, her memories are extraordinarily complete. I have referred her to Dr. Alan Schefflin for

I have sent written copies of memories to Dr. Alan Benjamin for validation and he has confirmed that she has knowledge of events and people that are not published anywhere, that some of her memories contain new information and that some are already known and published. Some of her memories have been confirmed by family members. She has also shown me old scrapbooks where she wrote notes to remember what was happening to her and hid the notes under the pictures in the scrapbook.

I was born in 1950; adopted at the age of two and one-half into a wealthy, middle-class family; and considered myself fortunate. By the time I reached the age of seven and one-half, I had become well accustomed to my life as an abused child. After years of being molested by my mother and her circle of friends, I believed I had already learned everything anyone could about living in Hell. I was wrong. Nothing could have prepared me for what was about to follow.

Between the years of 1957 and 1984, I was to become a pawn in a Government scheme, whose ultimate goal was; mind control, the manipulation of human behavior and ultimately, to create a human prototype of "the perfect spy". Through the use of chemicals, radiation, mind-altering drugs, hypnosis, electric shock, isolation, sleep deprivation, brainwashing; and sexual, emotional, physical and mental torture- I was exploited unwittingly for nearly three decades of my life. The only explanations

...and justifies the means; and - I was serving my country in their bold effort to stop Communism from spreading to my fellow Americans". I can only summarize my circumstances by saying; they took an already-abused seven year-old child and compounded her suffering beyond comprehension. The saddest part is- .I know for a FACT; that I was not alone. There were countless other children in my same situation and; there was no one to help us...until now.

In appreciation of the valuable time you have allotted myself and others, in bringing this urgent matter to your attention; I will attempt to be as concise and accurate as possible. In the following portions of my statement, I shall be supplying you with the specific projects (several of which contain the use of radiation) names, dates, specific places utilized for these projects; project and sub-project numbers; names of key persons involved and their functions; purposes of the operations and subjects used. Of course, it is the children, who I am most interested in drawing to your attention. They were not only abused children, such as myself, but well and disabled ones; of a variety of socio and economic backgrounds. It is only because of my photographic memory and dissociative abilities; that I am able to report the following information in such graphic detail. However, the process of recalling these atrocities is certainly not an easy one; nor is it without some danger to myself and my family. Therefore, it is my sincere hope; that you will hear me out and bear with me. To me...the risk is well worth it.

***FIRST: THE SUBJECTS OF THESE EXPERIMENTS AND HOW AND WHY THEY WERE CHOSEN.**

- Most were females between the ages of five and early thirties.
- Children are easily intimidated, coerced and obviously, easier to control than adults.
- In the event a child breaks the silence, their stories are usually ignored or seem unbelievable.
- Abused children, especially if initiated to sexual abuse at an early age are " expected to perform and tend to fight less".
- If introduced to an incestuous relationship early enough, children learn silence, shame; and are made to feel guilty and deserve some form of punishment.
- Abused children crave attention. When they are forced into a maternal incestuous relationship; they tend to crave the attention especially by a paternal figure, and will do ANYTHING to obtain it.
- A child, who has never been rewarded for " acceptable behavior" does not need to be retrained. They already learn that "unacceptable behavior" is often rewarded.

-As Dr. Martin T. Orme once said (in front of me at age eleven or twelve), "Chrystal here is a gold mine....she's ours to manipulate, straight from the crib to the classroom to the bedroom. The perfect little whore for any red-blooded American male!"

-Dr. L.Wilson Greene stated once that, "it WAS true...ALL females subconsciously fantasize about being controlled and even raped by a father figure".

-When sent in the "field as future honeypots", Richard Helms said, "men tend to talk more freely about their personal lives, jobs, secret desires and God knows what else. When involved sexually with a very young female...they never even realize they're spilling their guts."

-Differential amnesia can be used, "Dr. E. Cameron said, "and painful memories are repressed. Also spitting can occur and the host child (personality) honestly has no memory of the recent event; while the 'other' split, can be trained to retrieve information, when proper signal is given. One hand has absolutely NO idea what the other has done!"

- Doctor- L.Wilson Greene, said directly in my presence to Dr. Charles L. Brown Jr. (who 'volunteered' to become my constant monitor until this day; in return for taking sexual favors from me whenever he felt like it- he was a close "family friend" and thereby above suspicion), "These kinderkund-children are the easiest to train. AND the cheapest ones to work on. Also, they are much more fun than soldiers or loonies or prisoners. Besides, I LIKE scaring little children. It gives me a feeling of being a god to them and to the agency too. ...creating little robots to use for whatever deviant purposes they can think up...and Sid (Gottlieb) and James (Hamilton) can really come up with some doozies!"

-During the year after I turned eight, I was told I needed to be tested by some very " important doctors ,who were coming from a place called the NIH ; from as far away as New York City and a group of scientists who belonged to a Society (Human Ecology Society). " Also, I was told to be "on my best behavior, do as I was told and answer any questions they might ask truthfully; and try not to pay too much attention to the people's faces or names. This was a very important **SECRET** and sensitive operation they were working on for the President and a Deputy of an important organization in Washington, D.C. In order to help me forget everything(I was told the tests might hurt), I would be given shots and x-rays and maybe a little jolt of electricity; but I was to be brave!" Naturally, as most children do, I made certain to do the opposite and remember as much as I possibly could.

After the tests and before I was shocked and placed in a tub of water in a dark place called the "sleep room" at the hospital(Tulane University Medical Hospital), I overheard Doctor Greene and MY Doctor(Dr. Robert G. Heath) speaking with the group of physicians and men in suits and Army uniforms. Dr. Greene said, "She has a fertile mind and according to her hypnotic abilities,she is perfect for their needs. I must admit, I have collected a great deal of information and I am sure that she will be a great asset to our work."

A man I learned was called John (Gittinger) said according to my P A S 's, Wechsiers and remarkable scores in the digit span tests, all indicated I had innate abilities needed for this project. * Someone else responded with a remark as to my age and the man ,who had called me "Lassie" (whom I came to know as Dr. E. Cameron) stated, "It's just a matter of degrees. Age really has nothing to do with her usefulness. You must learn to overlook the fact she's only eight years old and have fun with your subjects!" Then I heard laughing as I remember crying inside. I had already learned NOT to show emotion on the outside, because you never knew what reaction or response would be punished or rewarded. By the time I was allowed to go home, I had already forgotten ever meeting anyone new ; taking any tests or being tortured. I recalled ONLY what Dr. Heath TOLD me had occurred over the past few days. My mind was already being controlled and I was completely unaware. Any bruises, burns, needle marks or even genital soreness, was always explained to me and I had no reason NOT to believe the kindly doctor, who always called me "Dear". In the words of Sid Gottlieb, "I was ripe for the Big A". ('A' meaning Artichoke, not amnesia, as I first thought, when these horrible memories began to surface

over two years ago.)

-Twice I overheard Dr. Greene and the people who came from a place called ORD (Office of Research and Development) discuss radiation in reference to a group of "retarded children " in New Orleans East and problems they were having with "leaks". When someone called Steve (Aldrich) notified Dr. Greene of the problem, there was a crude remark made by the man they jokingly called, "Stuttering Sid" (Dr. Gottlieb, who I came to know well over the next eight years. I learned to recognize him walking toward my room, because of his distinct limp. I also saw him often with the man known as Morse Allen, who spoke of creating a "tabula rasa"-his version of a human vegetable through the use of radiation, intense shock treatment and hypnosis.) ..that why was he so worried about a few retarded kids..."they were the LEAST likely to ever spill the beans". Another time I heard Dr. Martin Orne, while he called himself the "director of the Scientific Intelligence Office" and later the head of the facility called the Institute for Experimental Research and the APA" speaking to doctors Greene and Heath about demanding that "executive action" be taken when they were through with me as a test subject on controlling my mind with drugs, shocks, lots of hypnotic techniques he knew of; sexual humiliation and entrapment of all the top "echelon to insure the funding did not stop"; and even stepping up the stressors, such as chemicals, biologicals, increased use of the Variac (a portable type shock machine that could be used anywhere on a person's skin, as long as it was wet first); and even more x-rays. When one of my "splits", as they called my dissociated personalities- asked him what "executive action " meant? He

replied, "It means we get rid of the little bitch-YOU...don't you get it? You simply disappear. John (Dulles) can order that at any time and even Mac (John McCone) would never know what happened to you!"

TECHNIQUES UTILIZED FOR TRAINING AND INDOCTRINATION OF SUBJECTS:

-From 1958 until the late summer of 1959, I was tested by numerous doctors. That same spring, I overheard the Doctors- Gottlieb, Heath , Greene and a Phyllis Greenacre from Cornell talking about sending me away for a three week training program in Maryland. Dr.Greenacre had been consulted to determine certain "sexual problems or confusion I might have IF used in an exciting , but highly sensitive operation they were planning for August of that summer". She was to see if she could "assure Richard (Helms-Deputy director of Clandestine Plans-often called the head of ' dirty tricks') and 'Stormy'(a nickname I heard them call the man from California called Captain White ') that I would be acceptable for "certain scientific procedures in an operational setting". She asked , "What for?" Dr.Gottlieb said Morse (Allen) was anxious to begin teaching me entrapment techniques, which could be used in a couple of years...as soon as they decided I was not too young to be conspicuous to the unwitting targets." She said she and James (Hamilton) both agreed that I responded well to older men and external stimulation combined".

Although they laughed, I was excited to be going anywhere but home or the hospital

where I was still being abused by my mother's houseguests and numerous "terminal type techniques" (as they called the tortures we were subjected to at either the hospital or one of the Air Force Bases near New Orleans (and also the children in East N.O.). These terminal type experiments included :

*A combination of interrogation techniques involving a certain mixture of intravenous barbituates; followed by a stimulant; memory tests; shocks, isolation in huge tubs of alternating hot/cold water, degrading genital tests; followed by x-rays and/or long periods of no sleep with taped messages running. All this was followed by tests to determine if we remembered the series of tests!

*Sadistic harm avoidance tests(different types of pain to determine our tolerance to pain).


*Verbal abuse to lower our egos and increase our "needs to be dominated".

*Complete isolation from anyone else for long periods of time with only liquids to eat, which contained caffeine to increase amnesia.

*Sexual molestation by the doctors and Mr.Fenner, who was Chairman of the University board of directors at that time.

*Tactics to give us nightmares and then forced to remember them over and over.

*Electric shock treatment called a Page Russell effect using a machine called a Retter. This was always done the night before going home and combined with reminders that it was my mother who had hurt me..not the "good doctors". Whenever I woke up from the long period of sleep after shock treatments, I would have little or no memory of recent events; so Dr. Heath would supply the information I was to remember until next time. Memories would oddly return almost immediately after the first exposure to any pain or abuse. I was never allowed to see the other "patients" at Tulane; but I know they were mostly mental cases from Charity hospital or prisoners from Angola or other penal facilities, such as; Vacaville in California; Iona State in Providence; Lexington Kentucky drug rehab center run by a Dr. Isbell, who also was used as a consultant.

*Headaches were frequently long lasting and no analgesics were given. There was a

Doctor Wolff from New York or Boston, who was very small and skinny and wore thick glasses. He was consulted on "inducing headaches". Dr. Cameron was used as a consultant for the shock treatments and; later after I was told he "fell off a mountain about 8 years later," a Dr. Cleghorn took over all the shock treatments and increased the amounts and length . I remember the man called Morse(Allen) being especially fascinated with the shock and hypnotic aspects. Dr. Hyde from Boston was brought in for hypnosis and later Dr. Orne from the Human Ecology Institute. He and Dr. Brown (my monitor who often brought me back and forth from various places, had worked with Dr. Orne and Dr. Baldwin or Mateland at the NIH (National Institute of Health) in Philadelphia in the 1950's.) .

*A Col. Campbell came from Dayton and tested a new drug on me; as well as Dr. Hyde and the very tall man named George White, who later traveled with "Ike" and a young man named "Bud-the whiz kid", who set up cameras in hotel rooms to entrap high officials in Government ,Cia, Universities and also private donors of money such as Dr. Geshecker and J.King .(I don't recall where he was from). Also some local politicians and police officials were filmed just to keep the "funds going and the project going at all costs" .This was a quote from the man called Morse Allen. "Uncle John-as I was told to call John Gittinger) was the main person who gave me personality tests. He was a large man, who always wore a white suit and had a goatee and spoke with a funny kind of southern accent. The hotel rooms were kept year round all over the country(as Ike told me once) and the man with the gun and drank martinis and smelled

like smoke . George White, once showed me how there were cameras behind one of the mirrors in the bathroom which was hidden from sight. The other bathroom was open so no one suspected anyone was spying on me and whomever I was forced to stay with-sometimes all night. They were so certain my amnesia would last, they would often brag about their jobs and how important they were(the doctors or the agency men). Dr. Heath once told a visiting man from Minnesota, that he and Wilson (Greene) had perfected my amnesia so well, I wouldn't even remember my own name tomorrow...until HE told me what it was. I was given a fictitious name so he could make entries into files about my progress; AND enter me as a " private patient of his" at Tulane, "being treated for schizoid tendencies and aberrant behavior".

* My name from then on was Chrystal . At the Deep Creek Cabin ' camp' ,I was known as " Ava"- a name I was allowed to pick.

"My trip to Maryland (the first time in 1959) was probably the nicest three weeks of my life as their "S" or subject as I was called. It was beautiful there and no medicines or shots(except antibiotics) were given. No one was allowed to cause us pain and even the sexual abuse was limited. It was merely a one-to-one training period, where I was a "guest of Mr.Scheiber"-really Dr. Gottlieb and it was run by the head of "co vert ops", who called himself "Stormy". Most of the men I came to know well, were either there as observers or volunteer targets. We were taught different ways to please men and at the same time ask questions to get them to talk about themselves. Then, we had to recall everything about them-physical & personality traits; as well as repeat whole conversations. Later the movies , that were taken of us, were watched by us and the doctors (especially Dr.White or Captain White, Dr. Hamilton, Dr Wendt(the one they said wasn't really a doctor but an absent minded professor); a Dr. Moore from Delaware and even Morse Allen and R. Heims. The only person they said who was unaware of the cabin and Monroe's "unorthodox spending" was Mac or John McCone, whom they thought

would strongly object to the use of girls ranging in age from 7 to late twenties for "learning coercive techniques".

"After this trip, I mainly went to hospitals, Army or Air Force Bases or Universities or the hotels in New Orleans and a place called the TRIMS facility, which was in Texas and had a large "exhibition room". We were constantly having to display our progress throughout the next 15 to 20 years; so that "the top echelon wouldn't cut the budget any more or stop the projects altogether"-I was to overhear many conversations about the money and where it came from and was "Tulane and Dr.Heath putting their portion to good use?"(on me I guess, as well as the other innocent victims).

"There is much more I could supply as far as conversations and places I was taken to; and people I was forced to "please" or be tested by; but there is neither the time nor the space for this. I think that ,along with the names of the projects, I will have given more than enough information to warrant a further investigation of the mind control experiments.

-PROJECTS INVOLVED IN PERSONALLY AS "SUBJECT" OR LEARNED ABOUT IN CONVERSATIONS OVERHEARD AND/OR DIRECTLY TOLD TO ME:

-Whenever possible, I will include names of those participating in projects-

-The "Bluebird Project", I was told became from the "amnesia project called Artichoke" or "The Big A". It also included finding ways of determining if it was possible to lie under hypnosis. It was part of an "Umbrella...something" started about 4 years before I first met Captain White, Richard Helms or heard about the "Professor-Dr.Wendt".

-In 1959, when I first was taught to remember certain incidents & people by the cue:"THE BLUEBIRDS ARE FLYING".

-IN 1960, when I was 10, they spoke of a project called Naomi; which could "paralyze you by them giving you the K problem ". I believe it was only a tactic to scare me into obeying.

-When I was 12 (1962) I first heard them refer to MK Ultra; which Dr.Greene told me stood for

"war without death". It was also going to show "the Americans that WE CAN learn to control anyone's behavior if given enough time".

-The following year, in Mexico City, I heard the numbers subproject 128 and that I was "Subject(S)" either 1, 2 or 3.

-The man named Inspector Earman said they had a "third chance going with the drugs which could alter your mind"; and MK Delta meant it was all the most important parts of the Ultra Project like biochemicals, brain maps and brain surgery(which fortunately Mr.Fenner refused to let them do to me);electric shocks and different drugs to control behaviors; and also radiation to ensure silence somehow". I overheard a conversation between Drs.Greene and Heath after an "inspection" by the General (Earman).

-Something called MK Search was mentioned in 1965 as a way of studying germs to "kill people without them knowing they had been given gas and without using any weapons". I believe Dr.Greene was referring to 'Germ warfare '. Also he mentioned the large groups of children in retarded schools who had been given "doses of x-rays to see what would happen".

-All the people from the ORD place talked about was radiation(Drs.Orme, Gottlieb & Aldrich. Also the Morse Allen man, who seemed to be fascinated with hypnotism and said he "missed the early Artichoke days and talked about making "people into vegetables". and wishing "Esty(Estabrooks) hadn't chickened out of using terminal experiments!"

-I remember whenever Dr.Hamilton was involved in his "MK Search stuff and finding new and amusing ways to use sex for controlling people", the number Sub Project #2,3, 7 & 12 came up. .

-When money ran out from the government for the MK Ultra sub projects; they began using private funds and "Academia-" more to make the project seem more "sensitive and sound more important to the top brass". This went on til 1963(funding by the Government) then I began to hear more about "The Institute for Experimental Research" and "The Psychological Assessment Assoc. "run by "Uncle John"(Gittinger).

-Dr.Gottlieb ran something called the SOD (Special Operations...something...)and the TSD(Technical Services Division) of the "Dirty tricks department run by Richard(Helms).

-The TRIMS place in Texas I only learned of in the 1970's and I can't remember what it stands for but it was guarded by soldiers and the R was Research, I know that much.

-Finally, there was the Edgewood Chemical & Radiation Laboratory in Fort Deetrick. It was where Dr. Greene was always coming from or going to. It was East of the Cabins surrounded by water and called Deep Creek, where I stayed

-I think I was in numbers #74(Deep Creek) and 430 or #431-434(subprojects)..

It seems that due to a brutal sexual assault in my own home , by someone I had trusted, produced such similar stress; that I suffered from Post Traumatic Stress Disorder and was hospitalized after the incident in October of 1992. This single act is what began the slow emergence of these long-forgotten memories. I would like to make it clear, that I never sought to retrieve any of these remembrances or any of the information I had stored all these years. My therapist was recommended to me by the New Orleans Police Rape Squad as an " expert witness in court cases involving sexual assault". Although, I lost my battle in court against the perpetrator, and Mrs. Wolf was never allowed to

appear as a witness, I consider myself fortunate I happened to still be in therapy with her, when the bits and pieces of these past horrors began to slowly return. Never once has hypnosis been utilized; nor have I ever been told of ANY government projects by my therapist. In fact, I was the first one to even mention the CIA or the names of any of these projects or participants. The past two and a half years, I have been able to remember these instances of their abuses on me as a child ; while my therapist has been available to offer comfort, support and keep me safe during this time. Recently however, I have constantly been threatened, harrassed and had my life turned into a waking nightmare; all because I sought to validate my extraordinary memories by initially contacting Doctors Heath, Orme and Brown . Of course, this was BEFORE I recalled THEIR participation in torturing , sexually assaulting and controlling me throughout the first three decades of my life. When I confronted them with my memories, they threatened me repeatedly and I was assaulted and given drugs and shocks again ; in order to gain my promise of silence. Although Dr. Orme sent someone in his ' behalf to "personally give me his message" to "keep my mouth shut, discontinue my therapy and above all- leave HIS name out of RI" All three Doctors stated they would not tolerate their "reputations being tarnished by things that might have occurred many years ago, while I was undergoing , quote -treatment for childhood schizophrenia". I have been under the care of two psychiatrists and several therapists over the past two and-a-half years, who ALL have assured me I am not, nor was I ever schizophrenic. What I HAD developed as a defense mechanism was a dissociative disorder. I would love nothing more than to say I had dreamed all this up and need to just "forget it all"; but that would be a tragic mistake. Not only that, it would be a lie. All these

atrocities DID occur to me and to countless other men, women and children; and all under the guise of defending our country! I have spent the better portion of my adult life suffering from somatic symptoms, which - until now, could never be explained. I have undergone many years of pain (the worst being severe Migrane headaches) , treatment , needless surgeries, emotional distress, loss of income and most of all- betrayal by people I trusted and even loved. Because of the cumulative effects of government sponsored research, involving exposure to radiation, chemicals, drugs , physical torture and mental anguish, I have even been robbed of the ability to work and even to bear children of my own. It is blatantly obvious to me and hopefully to this committee; that none of this needed, nor SHOULD have taken place...EVER! We must work to ensure the safety of today's population of children, so that nothing even remotely akin to these acts of sheer cruelty and suffering , should EVER be allowed to happen again. The only means we have is to seek out the truth- no matter how evil or disgusting it is by opening whatever files remain and then, bring the awful truth out into the open . I believe firmly, that every citizen of this great Nation of ours has a right to know what is truth and what is fiction. It is our greatest protection against the possibility of this ever happening again! I thank you for your time and I leave this matter in your capable hands. I urge you to investigate these matters even beyond the radiation portion of these ghastly experiments and to appoint the appropriate people to look into ALL of the mind control research , which was done on unwitting citizens and innocent children. I know you will find it in your best judgement and in your hearts to take the necessary action. I can offer no more than what I have given

you today...the truth. Thank you again for your patience and time.

As Chris De Nicola's therapist, I wish to document the process of how she has recovered her memories of being used as a subject in governmental experiments involving radiation and mind control. All of Chris' memories have emerged spontaneously with free recall. No memory recovery techniques such as hypnosis or sodium amytal have been used. I was naked, strapped down on a table spread eagle on my back. Dr. Greene and Don Ebner put electrodes on my head near my temples, chest, stomach, legs, arms and back. Dr. Greene used electric shock on me. It was painful. He told me something about my having a choice that I could stab the doll outside which he said could have been a real child or he was going to use Radiation on my uterus to kill my chance of ever having children, that I would be killing unborn children. I told him I didn't want to stab the doll outside and take a chance it could actually be a child. Dr. Greene said something to me like "So you've chosen to kill any children you might have?" Using trauma, giving me messages such as I'm a murderer and a worthless insignificant bitch in between more trauma. He also used Drugs. A shot that made me drowsy and a shot that made me totally unconscious so Don Ebner could get me back home. Torture Techniques

I would like to preface the following with the fact that they had stripped me naked almost every time. I felt humiliated and ashamed.

The purpose of these torture techniques was to gain total control over my mind and body, and to split my mind into as many parts as possible so that they could mold me into a spy/assassin. Some of the torture techniques were used to ensure that I would never talk about what they did. As I resisted them more and more when I got older, Dr. Greene reversed the messages about being a spy/assassin and not only increased the intensity of the torture but switched the messages so I would become self-destructive, suicidal and have difficulty with therapists.

1. Severe electric shock all over my entire body.
2. Don Ebner brutally raped me on many occasions.
3. Peggy Ebner, his current wife, raped me and repeated to me that I preferred women sexually.

4. Tried to get me to believe I was gay knowing that I was heterosexual and had strong feelings against being gay.
5. Tied me down in a cage on my back and shocked me and left me alone in the dark outside.
6. Strapped me down on a round table naked, with electrodes on me, shocking me and spinning me on a table at the same time.
7. Tied me standing up naked spread eagle with electrodes on my back against a wall. Don Ebner shocked me. Then stopped and had intercourse with me and shocked me again.
8. Tied me down on my back in some sort of chamber. Put electrodes on my body and spun me and shocked me simultaneously.
9. Strapped me down in a wooden box on my back with electrodes on me. Dumped live bugs on me. When they used electric shock the bugs died.

Then put a lid on the box. Lowered it into a grave. Shoveled dirt on the box and Dr. Greene told me he was going to bury me alive.

10. Dr. Greene made me eat disgusting things and told me I needed to starve while he used electric shock on me.

11. Made me drink disgusting things and told me I couldn't drink while he used electric shock on me.

12. Some of the torture included something that stimulated me sexually while I was tied down and shocked.

13. Strapped me to a chair. Made me believe it was an electric chair. Put a helmet on my head with electrodes in it and put electrodes on the rest of my body and used electric shock while telling me I was going to die.

14. Strapped me down on my back in a cage, put electrodes on my body and dumped live snakes on me. Then shocked me and the snakes fell off me.

Dr. Greene then left me alone like that while continuing electric shock on

- me at a minimal level.
15. Held me over a pit of snakes and threatened to drop me in with them.
16. Put me in a dark cave alone after being tortured with electric shock.
17. Humiliated me by putting a chain around my waste, ankles and my hands behind my back. Shocked me to the point that I fell and called me a wimp over and over again. Get up wimp. I couldn't get up. I had chains on me and I was being shocked.
18. Dislocated my shoulders, wrists, knees and ankles and then put them back in place.
19. Tied me down naked in a box on my back and dumped itching powder on me.
20. Basically hog tied me and electric shocked me at the same time.

21. Tied me down on some sort of a wooden table and stretched my body...arms and legs until it hurt and then left me there alone in pain. Then returned and stretched me more.

22. Tied me to two poles spread eagle. Stretched me as much as they could. Put shots in my stomach around my belly button. Also put shots in other areas of my stomach and my back as well. Then used electric shock on my body.

23. Had me in a building that looked like a psychiatric ward. Dr. Greene taunted me and tried to make me believe I was crazy. He had me put in restraints on a bed. He gave me various shots. One that made me drowsy, one that made me unconscious and another one that made me feel and act crazy. It was like I was hallucinating. He told me I was crazy and would be locked up in a psychiatric hospital the rest of my life. He took me from there to an elevator to another floor where there was a dark room with a spotlight on some sort of platform. I was standing spread eagle and tied between two poles and Dr. Greene used electric shock on me. Sometimes would leave me there and my arms would ache from being in the restraints.

...leave me there and my arms would ache from hanging there for so long. Sometimes he put shots in my stomach on these occasions. Then he would give me a shot in the arm and would take me back to the elevator down to the psychiatric ward. Sometimes he would make himself look different somehow and act like he was a psychiatrist who really wanted to help me. He would talk to me while I was in restraints on a bed on my stomach. He would say if I would cooperate I could come out of restraints. So he would have people dressed up like nurses take me out of the restraints. I cooperated briefly and then tried to escape and his assistants would grab me and throw me back in restraints. The whole sequence of events made me feel crazy. Dr. Greene also used a red light while I was in restraints on my back and used post-hypnotic suggestion that I was crazy and would be institutionalized for life.

24. Put shots in my belly button, the center of my vagina and in the nipples of my breasts and other areas of my breasts as well.

25. Put electrodes inside my uterus and the rest of my body and shocked me.

26. Frightened and humiliated me in many ways from the torture techniques described above. Also, humiliated me and created a sense of hopelessness in me by calling me names like wimp, bitch, insignificant bitch, insignificant worthless bitch and other degrading names.

27. Used post-hypnotic suggestion to ingrain over 100 negative messages about therapists and psychiatrists so that if I ever went to seek help it would make the relationship very difficult and discourage me from getting help. The negative messages have been very difficult to fight and have put a strain on my relationship with my therapists. In fact, I was fired as a client by a couple of therapists because of my behavior as a result of those negative messages. They were therapists who did not know about Mind Control. Even though my current therapist understands about Mind Control and the negative therapist messages ingrained in me, the messages are strong and create a strain on even our strong working relationship.

How All The Experiments/Torture Have Affected My Life

As a child I lived in fear. Dr. Greene and Don Ebner threatened to kill me, my mother and even my dog. As far back as I can remember, I just wanted to be dead. I still live in fear at times.

At age 11, October of 1973, I was admitted to Tucson Medical Center for tests. I had complained to my mother that my legs hurt initially. Then I complained of pain in my right knee, then my left knee, and then my right knee again. The pain got so bad in my right knee, I could not walk on it. That is when my mom took me to my pediatrician and he recommended I be hospitalized immediately. I had a low grade fever, slight swelling and severe pain in my right knee. Specialists came in to examine my knee but they couldn't figure out what was causing my symptoms. After a few days in the hospital, the pain subsided and I was able to begin to walk again. After about a week, I was able to walk fine. The physicians were puzzled and finally just diagnosed me with a virus and released me from the hospital. I believe what happened had to do with the torture I was enduring, whether it was radiation, electric shock, I don't know. But in

looking back, the excruciating pain I felt in my knee was very similar to the pain I felt when Dr. Greene performed different experiments on me. I just can't identify which one.

As a child I was very thin and it was very difficult for me to eat. My mother agonized over making things that she knew I liked to get me to eat. My mother nor my grandparents had knowledge of the experiments I was being subject too in the middle of the night by Dr. Greene and Don Ebner.

In school, my grades were C's and D's. I tried as hard as I could but I just couldn't concentrate. It wasn't until about 1974 when my grades went up to A's and B's. I attribute this change partially to the fact that I had developed my photographic memory as a result of Dr. Greene's experiments but I think most of it had to do with the fact I had come to some sort of peace. That I wasn't going to give in to Dr. Greene molding me into a spy/assassin. By that time I had made a conscious decision to totally resist. He could kill me or not kill me. I didn't care. So even though the experiments continued until 1976, my grades got better

because I felt some sort of peace within me and I was able to focus better.

Because of the countless messages Dr. Greene ingrained in me, the following outlines the negative affects on my adult life:

I developed Multiple Personality Disorder because Dr. Greene wanted to split my mind into as many parts as possible so he could gain total control of my mind.

I couldn't go to college no matter how hard I tried. I tried to take several classes and I would be doing very well in the class, then half way through something would happen and I would have to drop out of the class. I usually got very depressed and ended up in a psychiatric hospital because of suicidal ideations.

I have been consistently in therapy for 12 years, the last two and a half years with my current therapist at a pace of 5 days a week.

I have been hospitalized as an inpatient in psychiatric hospitals approximately 26 times in the last 9 years. Almost all of the hospitalizations were voluntary, with the suggestion of my therapist at any given time. I knew at those times I was unsafe. Approximately 7 of the hospitalizations were 4-6 weeks long. Two were for Anorexia. The other hospitalizations were 2 weeks or less. The more recent hospitalizations specifically had to do with memory work that I felt would be too difficult to do outpatient. At these times I elected to go into restraints in order to get through the memory safely because of the violent intensity of the memory.

Even with inpatient treatment for Anorexia in 1986 and again in 1993, I still had been Anorexic for 2 years straight up until about 4 months ago when I was able to begin to get my weight back. It was just difficult for me to eat. Nothing tasted good. I felt nauseous a lot of the time. Physically I was dwindling and I didn't feel well. It got to the point several times where I couldn't think clearly as a result of the Anorexia. I believe it is a result of undoing a lot of the messages Dr. Greene ingrained

in me about starving that 4 months ago I was able to begin to eat without so much trouble.

Over the last 5 years different parts of me have taken three major overdoses. Prescription medication along with champagne on an empty stomach. Specific messages ingrained in me by Dr. Greene. I had to have my stomach pumped on all 3 occasions and literally almost died from two of the overdoses. When the paramedics found me on one of the occasions I had actually stopped breathing. The last overdose I took was in March of 1993 and I was in intensive care for two days. The irony is that I didn't want to die. Nor do I want to die now.

In September of 1993 one of the parts of me hog tied me to the bed and put a chain around my neck connecting it to my feet and put my hands in handcuffs behind my back after drinking some sort of alcoholic beverage. I was able to get out of it, but was diagnosed with a Larynx Contusion. It took 1 year to heal totally. It is still sensitive and recently I injured it again accidentally in the course of reliving the violent memories. Again, diagnosed with a Larynx contusion, it will take time to

heal. It is a strain to talk and although I like to sing, I can't because it is too much of a strain and hurts my throat too much.

In May of 1994 one of the parts of me stopped drinking water or any other kind of fluid for 12 hours. I was o.k. but then the following week they did it again only withholding liquid for 24 hours. I couldn't urinate and ended up with a kidney stone as a result. I was in severe pain.

July of 1994 one of the parts of me felt they were supposed to jump in front of a train. By that time that part of me had enough information to know it would kill me; however, was in a trance state and watched the train. That part of me modified the message to jump in front of the train by trying to jump on the train. I was able to grab hold of the train with my hands but my feet didn't make it onto the train. I was dragged for quite a few feet on rocks before the engineer of the train stopped and I let go. I went to the emergency room. I was fortunate in that I only bruised and severely strained muscles in my neck and the entire right side of my back. I went to physical therapy for awhile and it pretty much healed.

But just recently I aggravated the muscles again by accident.

I've developed a permanent, slight curvature in my spine from being in constant physical, mental and emotional pain.

The physical pain and the self-destructive messages implanted in the memories surfacing make it unbearable for me at times. I work hard everyday to keep the other parts of me from following through with self-destructive messages ingrained in me by Dr. Greene. Such as taking prescription drugs, with champagne on an empty stomach and not calling for help. Slitting my wrists, starving, not drinking, trouble sleeping (if I go to sleep I'll never wake up.) Getting into a bathtub filled with warm water and turning on an electric blow dryer and throwing it in the bathtub with me. These are but a few of the messages Dr. Greene ingrained in me. He wanted me to self-destruct or be maimed for life. He really wanted me to commit suicide because I knew too much. If I ever remembered what he did, he wanted to make sure I died before I was able to tell what he did.

I also suffer from

I also came from intense anxiety. Dr. Greene did to survive. I'm currently taking 1 mg. of Klonopin 3 times a day to help with the anxiety. The medication helps, but the anxiety is still intense.

None of the self-destructive behaviors I've engaged in have I consciously wanted to do. They were ingrained in the separate parts of my psyche; consequently, parts of me followed through with these behaviors. These parts of me, being separate, did not have the information that what they were doing was dangerous. Every part of me had been told by Dr. Greene that what they would be doing would help stop the pain, not maim or kill me.

As far as relationships go, I had been isolated emotionally from my mother for a very long time. Not because of her but because I distanced her because of the negative messages Dr. Greene instilled in me about close relationships, not only in relation to my mother but others as well. Relationships with men, therapists, etc. Dr. Greene's objective was to

isolate me from everyone in an attempt to reinforce the suicidal messages.

My relationship with my mother is much better now as a result of understanding and undoing the messages Dr. Greene ingrained in me and because both my mother and I never gave up on the relationship. We've both worked hard to keep the connection.

I am married to a man that I have known for ten and a half years. We've been married nearly 4 years now. Out of all that time, again because of Dr. Greene's negative messages about men, and other issues too, my husband and I have only lived under the same roof for a total of about 6 months. We currently are living separately. Out of all the years we've known each other our sexual relations have been extremely limited. However, we are working together on ourselves and the relationship to finally reach the goal of being able to live under the same roof and develop a true intimate relationship.

I was able to hold a full-time job with Disneyland for approximately

7 years. I worked my way into a Traffic Coordinator position with Disneyland Advertising but because of the constant flooding of memories and being in so much physical, mental and emotional pain I was forced to quit in March of 1990. I was completely overwhelmed and just couldn't focus on my work anymore. As a result of all of this, I applied and was granted California State Disability benefits from March 20, 1990 - April 13, 1991. At that point my full disability benefits had been exhausted. So, I tried to work part-time. I took one part-time job after another trying so hard to be able to focus and hang on to a job. Finally, I was granted partial benefits with California State Disability from approximately September 10, 1991 - March 14, 1992. I didn't receive much but it helped. I was holding a part-time job for part of that time but ended up having to quit because of the reasons I stated earlier.

My husband and I got married April 14, 1991 and even though we lived separately most of that time he helped to support me financially and he still does.

His job moved us out of California in July of 1992. We agreed upon living separately. Again, I tried to hold a part-time job. I held it for about 6 weeks and was forced to quit because of the reasons I stated earlier.

In November of 1993 I applied for Social Security Disability Insurance (SSDI). Within 6 months, without question, I was granted full benefits. They deemed me disabled as of March of 1990 because I hadn't been able to hold a substantial job since that time and it was obvious I had tried extremely hard to do so. SSDI paid me back benefits for two years (since that is as far back as they can go) and started my monthly benefits in May of 1994.

Dr. Greene and Don Ebner tried to create permanent barriers in all aspects of my life by splitting my mind into as many parts as possible and ingraining the negative messages around eating, drinking, sleeping, college, relationships, self-destructive and death (suicide) messages, etc. They failed to destroy me but as you can see my life has been extremely difficult

difficult.

As i said earlier, i am currentiy in intensive therapy with a therapist who understands about Mind Control and I am making excellent progress and healing. Given the information I've supplied, again I am asking you to *please* recommend an investigation on Radiation, Mind Control and Drug Experiments to make the information available to therapists and other mental health professionals so they can help more people like myself. I *know* I can get better. I know others can too, with the proper help. Please help us in an effort to prevent these horrible acts from continuing in the future. Thank you.

To Whom It May Concern:

My name is Alan W. Schefflin. I am a Professor of Law at Santa Clara University Law School, and a judicially recognized expert in mind and behavior control. I co-authored a nonfiction book about government mind control programs entitled "The Mind Manipulators," which was published in a dozen countries.

I am writing in support of the testimony of Claudia S. Mullen and for the purpose of encouraging the opening of secret government files on radiation and on mind control. I have been studying these secret programs since 1975 and it is my conclusion that there are at minimum hundreds, and most likely thousands, of American citizens who could benefit from learning that they were used as experimental guinea pigs in government research projects.

Claudia's therapist has been kind enough to send me, with her patient's informed consent, some of the pertinent records reflecting Claudia's memories of her experiences as an unwitting subject in these experiments. I have been able to confirm that some of the information Claudia has provided is absolutely true and could not have been derived from any published source. It is my belief that Claudia is proof that secret government

more expansive than government authorities are willing to admit.

I know that many of the stories that will be told by witnesses will sound unbelievable. Please do not dismiss them out of hand. I learned the hard way that, although there is much disinformation about mind control experiments, there is also much truth in the least likely stories.

Release of remaining documents on secret government experiments is in the public interest and would not threaten national security. It is time for citizens to again trust their government. Public disclosure would be the act of good faith to encourage that trust. Furthermore, and most important, there remain victims of these programs who deserve to have that victimization come to an end. Let the truth set them free.

It would be my pleasure to supply any additional information requested.



Dear Ms. Wolf,

Re: CIA and Military Mind Control.

Further to our recent telephone conversation, I am writing to support your presentation to the Presidential radiation committee and your request that an inquiry be made into the overlapping subject of CIA and military mind control.

I am a psychiatrist with over 100 publications in professional journals. My area of specialty is dissociative identity disorder (DID) (formerly called multiple personality disorder), a topic on which I have published two books, one with John Wiley and Sons.

and one with the University of Toronto Press. I have another book on the subject in press with the University of Toronto Press. Another book recently published by Wiley, of which I wrote about one third, deals partly with DID. I was the 1994 President of the International Society for the study of Dissociation, which has about 3000 members.

I became interested in CIA and military mind control when patients with DID began describing involvement in mind control research occurring on military bases and in hospital settings. Since there is no way to tell clinically whether these memories are real, I began to do background reading and research on mind control in 1992. I enclose a reading list of the materials I have read.

In an article in the April 1971 issue of *Science Digest* G.H. Estabrooks describes using hypnosis to create artificial DID in military personnel during World War II. The purpose of the DID was for infiltration and courier operations - the amnesia involved created a layer of security from defection and interrogation inside the subject's mind. Estabrooks describes inserting specific code phrases used to call out the alter personality holding the classified information, of which the main part of the person was unaware. Estabrooks also wrote a textbook on hypnosis that went through a series of editions.

Declassified materials describe a large mind control research program conducted by the CIA and the military from 1951 - 1973 under cryptonyms including MKNAOMI, BLUEBIRD, ARTICHOKE, MKULTRA, and MKSEARCH. I have in my possession about 80 of the 149 MKULTRA Subproject files, which I obtained through the Freedom

of Information Act. I am conducting ongoing research identifying the investigators on these projects, obtaining their publications from my medical school library, and filing Freedom of Information Act requests with the CIA on each deceased investigator of interest. Through this process I have amassed thousands of pages of published papers. I am able to tie together specific MKULTRA and MKSEARCH Subprojects with the principal investigators, the funding fronts used by the CIA, and the publications resulting from the projects - the funding was classified, yet much of the research was published in regular journals in sanitized form without the CIA involvement being acknowledged.

Some of the MKULTRA and MKSEARCH investigators did not realize that their grants were really from the CIA but others are verified as being witting of CIA involvement and having TOP SECRET clearance from the CIA in the Subproject files. Such cleared investigators include Carl Rogers, Martin Orne, and Louis Jolyon West.

Drs. Orne and West are still alive. Their C.V.'s list funding from many different military intelligence sources. They and many other still living individuals could be called to testify at hearings.

The techniques of experimental mind control reported by DID patients include use of hallucinogens, sensory deprivation and isolation, physical spinning, hypnosis, and other

methods, each of which is described in published reports arising from military and CIA projects run from 1951 - 1973. Published articles in my files include descriptions of administration of 150 mcg of LSD to children age 5 - 10 years on a daily basis for days, weeks, months, and in a few cases even years. Neurosurgeons at Tulane, Yale, and Harvard did extensive research on brain electrode implants with intelligence funding, and combined brain implants with large numbers of drugs including hallucinogens. In a paper I have, Dr. Jose Delgado at Yale describes implanting electrodes in the brain of an 11-year old boy and stimulating the boy's brain with a remote transmitter that had a range of up to 100 feet (this research was done in the 1960's). When a button was pushed on the transmitter, a specific electrode fired, and the boy would state that he was unsure whether he was male or female, and that he wanted to marry Dr. Delgado. This behavior occurred only when a specific brain electrode was stimulated.

I mention this research to underline how sophisticated and destructive much of the documented mind control has been. MKULTRA alone included four Subprojects on children - one was conducted at the International Children's Summer Camp in Maine by an unwitting investigator. The MKULTRA Subproject file in my possession for this project states that the CIA's interest in this research was in establishing contact with foreign nationals of potential future operational use by the CIA - the children who served as subjects in the project were as young as 11 years old.

DID patients in treatment throughout the United States and Canada are describing involvement in mind control research that is much more sophisticated than MKULTRA and MKSEARCH. It includes deliberate sexual abuse of children to make them more dissociative. Although the reality of this research is not documented, the possibility that it is real is so serious that a formal investigation is warranted. Although some or many of

the DID patients' memories may be distorted or inaccurate. it is not plausible that the CIA and military intelligence agencies simply stopped this research in 1973, as they claim. If it continues to the present, it must have become much more sophisticated.

I would be pleased to testify at length at any hearings on CIA and military mind control.

REPORT ON BEHAVIOR AND ACTIVITIES REPORTED BY MY PATIENTS
FROM 1988 TO THE PRESENT:

Personal statement:

Although I am well qualified in the correct use of hypnosis, the information I am describing in this document was told to me by my patients without the use of hypnosis. Hypnosis was used later to help my patients process these horrendous memories and rebuild their sense of self. The patients, as they processed their memories, would describe how they had been fooled or tricked with the use of goggles, virtual reality types of experiences, viewing of videotapes, drugs, hypnosis, etc. After I met Nazi alters, I read about Nazi thinking. Only recently have I read about the CIA experiments in publicly accessible books, particularly the Cameron experiments, and was shocked at the similarities and also the updates that my patients reported that appeared to consistently follow from what I was able to read.

These patients journaled these memories first. Some were "repressed memories" that came up for these patients through flashbacks, but the vast majority of what was reported to me were the memories of alter personalities that had never forgotten. What happened to them had not been allowed to be shared with the host. Amnesia was very successful in most of these patients until they felt they were in a safe environment and could begin to tell. All of these patients felt that they would not be believed and had been told that by their

perpetrators. At first, I had all of the normal disbelief in this information, but over time as patients reported the same information time and time again in detail (and I also had corroboration such as an item left at someones home to scare them into silence, the black shock box, described below, a written warning found on my car,) I personally began to believe in the overall reality of this. I never knew whether the individual memories of my patients were true or not true. My role was to work with them to come to their own conclusions. What I did know is that these patients presented with all of the symptoms of individuals who had been terribly traumatized, tortured and humiliated to the point that alter personalities were formed, the symptoms of severe post traumatic stress disorder and other severe psychiatric disorders were found. These patients were very frightened in the telling of what had happened to them

Personally, I never wanted to know this information and it was never a part of my clinical or personal world. I did not know what humans were capable of doing to humans. I have recently read the works of de Sade and have more of an understanding that humans are the only species on this earth that purposely torture their own kind. I was naive not to have known this, but I had sheltered myself and my children from horror films and violence and did not grow up knowing about anything violent other than that the Holocaust had taken place. It is with fear that I share this information. I am afraid it will fall into the wrong hands, that I will somehow be identified and harmed more than I already have been. My life has been threatened many times, patients have attacked me, patients have told me they were sent to attack me, kill me or discredit me. I have been accused of implanting all of this in my patients. I did not nor do I think it is possible for me to have implanted these ideas. Working with these patients, I heard things that truly shocked and horrified me and that I wish that I had never heard. I feel that I accidentally walked into a world that I was not supposed to ever know about.

Clinically, I am fully aware that patients are suggestible, that I have a responsibility to be careful and not lead my patients to conclusions about their experiences. I used their words to describe their experiences and that is one reason why it took me time to figure out that they might be talking about mind control techniques but using different words like "cult" or "programming." I feel that I abided by this during my care of these patients.

This is only an outline. Details of the forms of abuse would take pages. More was reported to me and I have lists of names, dates, locations, but am reluctant to share more than this unless at least this much information is taken seriously by someone that I can trust.

General Overview and Common Traits:

- 1. Approximately 100 patients have been referred or have self referred for psychotherapy of varying time lengths or for consultation, over the last 6 years.**
- 2. At first I saw patients that resided in and around a major southern city. Later, patients were referred from all over the United States. I have also seen many patients in consultations that other therapists have brought to my office with specific therapeutic questions.**
- 3. Regardless of where these patients lived, they reported the same basic information. Common traits were found in most of the patients who reported or described participating in what appear to fall into the classification of radiation or mind control experiments.**
- 4. Patients reported that the list of experiences below were among the ways that multiple personalities, operatives and amnesia were produced within their personality structure.**

ECT was used on various parts of the body, usually the physical places that do not readily show or in tissue that heals quickly. Patients told me no scars were to be found. This included the head, teeth, ears, the nipples, vagina, rectum and other parts of the body. A cattle prod type instrument was used to train patients to behave in certain ways.

Most patients described a helmet they wore that was related to both ECT and to sounds, such as taped messages in their ears, intense pain, disorientation, isolation, etc.

Goggles were often described that show colors or complete blackness as a part of sensory deprivation.

Goggles that gave the impression of "virtual reality" were described by my patients long before that concept was on the market. They reported that these goggles were used for them to view images that terrified them, made them think they had done horrendous things, including committing crimes such as murder, cannibalism, and also the images were used for blackmail purposes. ("You did this and we will send you to prison if you ever tell.")

Sensory deprivation in the home included closets, laundry hampers, drawers, and being locked in car trunks. Outside the home, this deprivation included totally soundproofed rooms and no light. They reported a sense of being left for hours or days in isolation with no human contact. They were left in a room on LSD and other drugs or used sexually while on these drugs. Patients report being held upside down in what is described as a black hole as a means of sensory deprivation.

Some patients described a hyperbaric chamber where the pressure changed and was very painful to them.

Immersion in water was used including being shackled in a cage, with a helmet, goggles, and a sense of being able to feel pain and then eventually not feeling anything at all.

All patients described black "shock" boxes that were a source of electroshock and used by perpetrators on them or that they used at home on themselves. Two of them have been turned in by patients of another therapist in my area. So far, one has been examined and was traced back to the CIA. Most patients were trained to torture themselves in places that do not show. (Inside the ear, nose, mouth, vagina, rectum) The black box that was turned in to a therapist was a source of voltage. It included two attachments that could be connected. one was a long cord with a two pronged end that could be placed anywhere in the body and the other was a converted curling iron. I personally saw this equipment. There is a videotape of the patient describing the use of this apparatus, her explanation as to why it is that she used it on herself regularly and an analysis by a certified electrician in regard to the complexity of the internal mechanisms. The electrician felt the patient could not have made the devices herself. Patients have turned in other devices to therapists that they report that they use for self-torture that are usually normal house hold items such as curling irons, and other ordinary easily purchased items. The patients reported that they were programmed to hurt themselves and had to do it.

All of the patients said that the ECT and other forms of torture mentioned above were used to create multiple personalities that have specific jobs. Lipton's concept of "doubling" enters in here. The patients reported that they have a group of alter personalities that lead their normal life. They have other parts that are trained or programmed to be prostitutes, be involved in pornography, run drugs and money within cities and across borders and internationally. Some patients reported that they had "operatives" with separate identities, social security numbers, passports, etc and had jobs in other countries. They refer to specific people they have to kill, bombs to be planted in certain places and how they will not be suspected because they are usually young or middle aged, white and female and not the profile looked for in these types of crimes.

Most of the patients reported that they were forced to be active perpetrators from a young age, to do to others what had been done to them. They were then told that they were just like those who had harmed them and that they would go to prison if anyone found out.

5. Clinically:

Most of these patients had pseudo grand mal seizures with full tonic, clonic movement and apnea, up to 125 of them in one psychotherapy session and they attributed it to being shocked through ECT by their perpetrators to create alter personalities. Those that were tested, had normal EEGs. One patient was tested while having a pseudo grand mal seizure and nothing showed up on the EEG. It appeared to be a body memory.

They had automatic behavior from very robotically trying to kill themselves in various ways, to trying to kill the therapist, to trying to leave the office to kill somebody else..

Most of these patients responded to certain sounds such as clickers, metronomes or just clicking the tongue or hand clapping. Patients would vacillate from calm to robotically asking : "who do you want me to kill?" depending upon the sound that was heard.

Most of them were programmed to resist therapy, create cognitive confusion and to later recant their memories.

Most of the patients had multiple layers of alter personalities with strong amnesia between certain layers, particularly the layers that had specific antisocial jobs.

The patients are terrified that if this information known they will be killed or have to kill themselves, their therapist, or their loved ones.

Those that have children are expected to start conditioning them at birth on the same plan so that most of the children of these severe patients, if allowed to be in treatment, were found to be MPD and described the same experiences as their parents..

The patients described torture from very early in childhood that persisted even during therapy since the programming does not permit them to stop what appears to be conditioned responses to act sado-masochistically.

Almost all of them describe a doctor or hospital setting, being strapped to a bed or table to have various experiments done to them including ECT, drugs, helmets, tapes to listen to, sexual assault of all types.

These patients described terribly demeaning, humiliating acts with the psychology being that nobody wants them, loves them and that their only hope is that their perpetrators will care for them.

Most patients described Neo-Nazi alter personalities who believed in the coming of the next Reich, had Nazi thinking, had alters named after concentration camps, Hitler, Adolph, other Nazi leaders and had a belief system of Aryan Supremacy. The thinking was clearly not something obtained except through intense brainwashing and not available to the general public.

6. More specific experiences that one or more patients reported::

A patient described situations where everyone wore the protection used by X-ray technicians except the patient. The patient thinks radiation of some sort occurred.

Patients reported being hung in a harness around the waist, straps around the upper body with straps in the area of the vagina and rectum. These were used to use ECT on the head, nipples, insert objects and ECT devices in the vagina and rectum. Depending upon the age of the patient, this was originally described as used for torture and complete control of the patient. Then, the patient reported that she was trained to be the perfect prostitute and to react in certain ways with certain men. Depending upon what was needed either as a prostitute or in a pornographic film, the patient was trained to react in certain ways, play particular roles and alter personalities were made to play those roles. This was done with

starting at around 5 years of age and being used throughout their life for training or punishment purposes. Patients reported that, in retrospect, this made the prostitution and pornography go more smoothly.

Many patients reported being trained to be "programmers" by the "Dr. Green" which included starting with young children and using various quite involved techniques to mind control their subjects. The purpose was to create operatives, multiplicity and amnesia about all that happened. Any deviations in behavior were to be corrected by "adjustments" or further torture with ECT and other very painful tortures.

Most described routine use of a torture table where they were strapped down and then a variety of the above tortures were used depending upon what was needed.

Recruiting of children and adults into this situation was also reported by my patients. They described going to malls and other places and seeking out vulnerable people. If appropriate, they acted as a prostitute and also gave free drugs to get them locally involved. Others, especially the homeless or out of work, were promised jobs, given bus or airplane money and put on a bus or airplane. Usually from this city, relocation was reported to be to the Colorado Springs, Denver area.

Almost all patients reported being chained or shackled so that the patient had to remain on hands and knees and then made to have sex with specially trained dogs. After the training, this was used in both activities involving prostitution and pornography.

Almost all patients described being kept naked in cages while waiting for many of the above activities to occur to them while watching it happen to others.

Patients described enemas, being made to eat their feces, drink their urine and have their mouth used as the toilet for others in totally breaking down the person. This was also reported to be used during prostitution and pornography.

Many described mandatory family participation at home and particularly in front of others and in pornographic films. It was reported that sibling acts and parent child acts were especially valued by the perpetrators.

Some patients described an "arena" where spectators observed combinations of sexual perversion. This was always reported as very important, with important people there including foreign dignitaries. This was followed by individual prostitution in well decorated rooms. The patients believed this happened in this city and in Denver or Colorado Springs.

A few described planned murders by operatives and discussed future murders and bomb sites picked.

Many named military bases as locations for these experiments. especially in the area between Austin and San Antonio and Colorado Springs. They also named medical centers and hospitals and universities.

Full family involvement was expected where the parent was expected to include the children and take them to be programmed at a very early age.

Some patients provided a long list of names of people involved in these activities. These were often the same names from patients that to my knowledge had never met. This list included doctors, both local and in other cities that were the "Dr. Green" and described as specializing in torture

Other doctors aborted fetuses that were used for various purposes or took care of any problems involved with the torture to make sure the patient was well. could go home and not have to visit another physician.

Some patients lists of people involved included government officials, important people locally as well as ordinary citizens and many children. Many patients reported that they had to report in to a "Master" on a regular basis to make sure everything was correctly

followed. All patients with a master talked with great reluctance and fear of their master and few identified them by name. Patients reported that people involved often did not use their real name or went by their maiden name or middle name.

Many patients reported an organized system placed inside them by "Dr. Green" so that they reported themselves as being programmed or mind controlled. They reported that sounds, hand signals, messages and sounds over the phone, certain dates, etc.. would cause involuntary behaviors to occur. Usually the host or presenting personality was amnesic to this programming and the activities done were contrary to what the host ever wanted to do.

I hope this is helpful to you in serving to help victims of these forms of abuse.

After working with Disassociative Disorder clients for five years, it became apparent that there were some differences in the recovery process, the feel of their energy, and difference in layers/dividisions of altered states within their system.

When I began this work in January, 1990, I had heard little of Satanic cults and/or medical experimentation or even systemic and sadistic abuse. Clients with Satanic cult/KKK/witchcraft organized crimes connections seemed to be able to break through the programming, once safe in a hospital or away from the groups and to be able to move through memories and find a spirituality that helped them in the process of healing. When clients talked ^{about} computers, cold sterile rooms, hospitals, doctors, military procedures and training; the memories were more difficult to access. These clients had a much more flat affect, more depersonalized and had a more difficult time finding a spirituality to help them in the process.

Repeatedly, I kept hearing some of the

...I kept hearing some of the same procedures: spinal taps, experiments in water and other flotation tanks, EKG, EEGs, drugs (especially nicotine and hallucinogens, electrical shock treatments, including putting tubes down the throat and shocking to stop the heart and other functions). Many talked of needles and medication being put in the brain cavity and other parts of the brain cortex to be stimulated to ascertain pain tolerance, disassociative tolerance and other functions or lack of functions. Experiments with colors and lights were used a great deal as were mirrors to distort reality and to test clients' ability to repeat numbers and words. As in the cult activities, extreme sensory deprivation and sensory overload were used to distort reality and to confuse the senses. Every mind control technique known, has mentioned by the clients and others not known *before by this therapist.*

Repeatedly information about being in intelligence and/or warfare became a common theme. Clients have had memories of going to Boy/Girl Scout camps to learn warfare techniques and being in government underground facilities.

One client told me that they were made to believe they had been abducted by UFOs, so that if memories were retrieved, they would be discredited by the community.

Each one with the military mind control/experimentation had been trained for specific purposes..scanning computer information, accessing secret codes from computers, assassination of whoever they were told, couriers, prostitution/escort services to seduce government/political officials for information and blackmail purposes.

Several talked ^{about} "glowing in the dark", being given something... drug or radiation and watched by medical personnel to assess their reaction. Several talked of genetic experimentation... one miscarried in her early 20's and wasn't allowed to have a D & C until the doctors attempted to save the fetus that they had genetically engineered.

It also became clear that there were some common backgrounds of

these clients...their caretakers/parents had connection with the Masons (money, influence and political connections) and all branches of the military...Navy, Army and AirForce. A couple of clients have memories of hearing their parents being paid to utilize the children or they were given free medical care.

Intricate programming codes included Greek Alphabet, Kabalistic terms, colors, numerology and semiprecious stones. Many of the codes were common terms to keep the clients programmed and confused in everyday life and basically amnesic to the mind control information.

After the client has presented dreams and memories of medical mind control/experimentation, to verify their being programmed, I have put them under a deep trance and asked anything about "Alpha". It becomes clear very quickly if they have this background. Usually, an alter appears angrily/fearfully about being discovered. Because of the danger of flooding them with memories and overwhelming them with programming, I have not used hypnosis after that and have allowed the client to take their own process time to access information and memories at the speed and rate that they can handle it. That has seemed to work better than using a systematic approach to hypnosis, especially for outpatient work.

After working extensively with thirty five (35) clients and six children with systematic and sadistic abuse and disassociative disorders, thirteen adult survivors are known to have the mind control/medical experimentation.

For the purpose of this report and the hearings, I will list the clients with memories of radiation poisoning/injections. I will list the doctors and locations as the clients have given. Because I want to protect their identity and mine, because we are all well aware that I am being watched and monitored about who and when I see the survivors. I will attempt to list the salient facts in a concise way, to be used for the hearings.

CA, 39 year old female, born in 1955 in Oakland, Cal at the Naval Station. She grew up in Colo. where they moved immediately after the birth and her father, in the AirForce moved them between Gunnison, Colo., Pampa, Texas and Amarillo, Texas. She has memories of being the underground facility in C. Springs, NORAD, as well as her AirForce work at the time.

facilities in Nev. Information that she has secured includes that both parents were hypnotized and told that she would be made available to them at any time, in return for the government leaving the other children alone. Her father was also used as an experimental subject and was periodically in and out of state hospitals for mental breakdowns. The family was drawn into this by her paternal grandfather in Pampa, Texas, who had been in trouble with the government and was immunity for the use of his son and the children. She had information that she was poisoned by radiation as an infant in 1956 and subsequently by Dr. Volkenstein from Pampa between 1958 - 1961. She was told she had an extra kidney and had surgery as an infant. Subsequently it has been found that her kidney was destroyed by radiation and had to be removed within the first 18 months. Presently her ANA (Anti Nuclear Antibodies) are positive and she had ongoing health problems. She also knows that her uncle took her to Nevada every summer vacation and she was subjected to radiation poisoning from 1970 to 1974. The doctors who are mentioned frequently by her include: Dr. Rosenbaum, Dr. Greenbaum, Dr. Volkenstein, DR. William Mullens and Dr. Woolsworth Russell. She was also given hormone shots yearly and had a complete hysterectomy by the time she was in her mid twenties. She has had repeated occurrences of breast cysts over the years.

CWS, 42 year old female, born in 1952 in Waco, Texas. She had experimentation done as late as 1975 in Baylor University Hospital in Waco, when she was miscarrying and the doctor refused to allow D&C to heal, and insisted she be transported to the hospital where she has memories of them trying to save the fetus which had been genetically engineered and was supposed to become available to them when the child was three years old. It was the wisdom of the Universe that allowed that baby to be miscarried and the client was finally able to grieve that baby and why it miscarried, after all these years. She has memories of ~~strip~~ being used for heart experiments (she remembers the taste of bitter almonds). She remembers that the doctor made several mistakes...clotted her blood and she had damage of the pancreas and had another heart stoppage. She had radiation poisoning done repeatedly and cancer of the vulva was diagnosed in 1994 and she is currently in remission for that cancer. she remember spinal taps with radiation and many experiments done in hypberchambers and water containers. She has memories of

experiments being done on the brain and to see how far she would disassociate before coming back. She remembers being a part of experiments with several children and being used as examples in a classroom of the University Hospital. The doctors that she mentions are Dr. Avant, Dr. Greenbaum, Dr. Green and Dr. Cochran. A doctor Pastrel tried to make the kids more comfortable, but seemed unable to get them away from the experiments *at the University Hospital.*

CS- 41 year old female born in 1953, where many of the experiments occurred in Lufkin Memorial Hospital and Crocket Hospital in Texas. The child was given cobalt and radiation treatments for a skin disorder for the first six years of her life. As a four year old, she remembers her father telling her that the radiation was like "radio waves". By the time she was 13 years old, she had a ulcerated uterus and continues to have abnormal pap smears. She also had a great deal of gum and teeth experimentation and was told that a microphone was put in her molar area. Trauma done to her upper teeth and gums have been validated by subsequent xrays and the current dentist cannot figure out how the trauma could have occurred. She also has memories of her pituitary gland being injected with radiation. She has been told that she cannot have children, but no explanation.

She has memories of a nurse putting a needle in her neck and upper right shoulder in 1960 and not wanting the doctor to know what she was doing.

The doctors that she talks about are: Dr. Charles Evans, Dr. Trout, Dr. Temple, Dr. Kerth, Dr. Lupertz and Dr. Goldshe in Crockett, Texas.

Her father traveled all the time and the memory is that her mother thought she was helping medical science by making the client available for experiments. She also has a memory that the experiments stopped because they were considered a failure.

CK, 38 year old female, born 1956 in Athens, Texas. The experiments were done at Tyler Memorial Hospital in Tyler, Texas. Her father was a veteran of WWII and had PTSD and was involved with KKK and the Masons. She has memories of the experiments occurring between August, 1961 and 1967, although she had was told she was born with 4 kidneys and one was removed at age 18 months. She feels that the radiation poisoning killed one kidney. The experiments that she remembers included seeing how

Much pain she could endure. She also has memories of learning how to memorize numbers, shapes and other codes. Much of her programming was done with food, so she has an ongoing issue with an eating disorder, fluctuating between not eating and overeating. The doctors that she talks about are: Dr. Claywater, Dr. Green and Dr. Holt. She also mentioned that the hospital was all green.

CKM, 30 year old male, born in 1965 in New York and spent time in Cleveland, Ohio and Dallas, Texas. He is beginning to have memories of being underground with large doors, huge computers and a hospital setting. He knows he has been poisoned by radiation but does not have the clear memories yet and has not mentioned the doctors or specific places yet.

CL, 47 year old female, born in Ohio, in 1947. Father worked for Manhattan project and when she was diagnosed with Disassociative Disorder, appeared to be relieved about a great secret but died very quickly and unusually of Alzhiemer's Disease. She believes that he could have had radiation poisoning, because of the progress of the disease did not make medical sense. She has flashes of underground labs, sterile rooms, halls and being trained as a soldier in the Navy. She has just began retrieving memories.

All of the aforementioned clients also had a history of a great deal of systematic and sadistic abuse from incestual parents and other relatives, history of witchcraft, Satanic cult, KKK, NeoNazi and other torture and abuse. One client feels that her father was abusive to her so that he couldn't become too attached since he had been forced to take her to the hospitals. That seems to have some merit to it. It also appears that if parents were blackmailed to just did it for "God and Country", it was a part of the whole picture where their child was dehumanized and treated like an object and served the parents' needs.

Several of the clients are just now getting the memories and so they are incomplete, but I have included the ones that have definite memories of medical/mind control abuse. Only two of the thirty five, did not have other systematic abuse... one's mother was schizophrenic and thought she was helping the country and the other person was sexually abused by various members of the extended family over a long period

of time.

Dear Mr. Klaidman,

This letter is a follow-up to our March 15, 1995 conversation following my testimony at the Presidential Committee on Radiation. As you requested, enclosed is more specific information on Chris DeNicola and Claudia Mullen's knowledge of projects within the government, with specific information on where radiation files might be hidden.

I want to take this opportunity to thank you and the staff for allowing us the opportunity to testify. The feedback that we received from the audience is important for you to know. Many people came up to us and said that their loved one who had been exposed to radiation had talked about mind control techniques, but

that they did not know what they were talking about. Other radiation victims shared with us that they had been subjected to mind control as well. At least one person knew Dr. Orne and several others knew Dr. Greene's name. It appears that some of the radiation victims have been focusing on radiation and not realizing the importance of the mind control techniques that were also done with them. We have focused on mind control while hearing about radiation. The overlap between the radiation and mind control experiments may be greater than we had realized.

I would like to recommend that you call Alan Schefflin, JD, Professor of Law at Santa Clara University to get more specific information. Enclosed is a copy of his resume. He is the foremost expert in this area in the country and he has been researching CIA and government files for 20 years. In fact, it might be useful to you and your committee to have him get the clearance to research the files so that he can assist you in researching the files. Because he is familiar with the names and information and how it all cross checks, he may be able to find out information for you on the radiation experiments within the mind control files quickly and efficiently, since I know that your time is short in terms of finalizing your report. He is willing to be of assistance to you in any way.

John Kelly informed me that the CIA did its own internal investigation of the mind control experiments in 1978. Would it be possible for your staff to help us to obtain this report?

I have summarized Ms. Mullen's knowledge of the projects in the attached pages. Some of what she has remembered has turned out to be highly accurate according to Alan Schefflin. I have enclosed the information from Ms. DeNicola. The memos that she remembers were addressed to various military personnel in Bravo Division and to people in Internal Affairs of the CIA, which is maybe where the information is located. The dates of the memos she saw range from 1951 to 1973.

I hope this information is helpful to you. Please understand that therapists and victims of the mind control projects all over the country are being harassed and intimidated into not talking. Claudia Mullen, who also testified, is being harassed almost daily through the mail and telephone calls from Tulane University and from a pay phone in the offices of the person who was assigned to make sure that she does not remember. In the past month, words and symbols have been written on her house and car and threatening notes have been left on her car. One time they wrote the word DIE! with the name CRYSTAL, which was her pseudonym in the mind control projects. The only other people who know this name are her husband and me. With this kind of ongoing intimidation, she showed great courage in coming forward and testifying.

Some therapists who work with these clients are being sued on frivolous charges in an attempt to scare us off from treating them.

We have no choice but to continue to seek an investigation into the mind control experimentation so that we can all feel safe and continue to treat these clients and to help us to understand certain issues. First, how much of what they are telling us is true? Second, given current scientific controversies regarding memory and traumatic amnesia, what do the intelligence community and military research projects document about the capacity of the mind to develop amnesia?The clients are remembering their experiences now and this issue is not going to go away. I hope that your committee can help us to obtain an investigation.

**CITIZEN'S REPORT TO THE PRESIDENT'S ADVISORY COMMITTEE ON HUMAN
RADIATION EXPERIMENTS**


As a licensed clinical psychologist in private practice, I have treated three patients whose memories of childhood abuse include the detailed recall of sophisticated mind control technology being inflicted upon them by "experts" in collusion with the patients' mentally disturbed parents. The independent reports of these individuals contained similar information of an esoteric and intricate nature concerning mind control technology which in my opinion could be gained only through personal experience. I am submitting their letters to you because the non-familial perpetrators of their abuse may fall within the purview of the Commission's investigation, i.e., individuals who began mind control experimentation on citizens of the United States of America during the 1940's.

Having practiced psychotherapy for twenty five years, and served on the faculties of Ohio State University and the University of Virginia, I am well aware of the controversial nature of these patients' allegations. As a Diplomat of the American Board of Psychological Hypnosis I am knowledgeable in the area of human memory. My scientific training has led me to thoroughly scrutinize these patients' memories and conclude that the recollections are based upon actual experience.

Letters from Renee Bright and Christine Gentry (pseudonyms) refer to mind control abuse originating in the 1940's. Their dissociative material appeared to me to have major experimental or programming flaws, while the dissociated effects in John Smith were relatively precise, having been administered in the 1960's. I wonder if 15-20 years of practice yielded greater efficiency, the technology being refined as it was utilized by successive perpetrators?

I am available for testimony or other forms of input to the Commission. Please give this information your most serious investigation.

I entered treatment for depression with my original therapist in 1974, after eliciting a promise from her never to hypnotize or hospitalize me without my permission. When she asked the reason for my request, I answered that I could not trust doctors not to manipulate my mind, drug and/or kill me. I did not, however, know the basis of my mistrust.

Shortly after beginning therapy, I experienced the first of many "flashbacks" through which I was to recover memories. These memories seemed "stranger than fiction", since my family had always been socially prominent. I grew up in eastern Pennsylvania and the New York suburbs, my stepfather an executive board member of several national corporations. Yet, over the years, many of these memories were validated to a reasonable extent.

My first memories, in 1974, were of sexual abuse by my mother which began in early childhood. In late 1978, I began to recover memories of similar abuse by my stepfather. The memories regarding my stepfather, however, involved group sex, bright lights, electroshock, cattle prods, drugs, pornography, torture. My diagnosis until this time had been vague; I began to insist that I must be schizophrenic. My therapist revealed to me, in 1980, that I was MPD.

In 1986, I testified before *The Attorney General's Commission On Pornography* under a different pseudonym. In that testimony, I spoke of my stepfather's involvement in...

remembered being used by my stepfather as a specimen, or guinea pig, in some type of experiment in which my stepfather was involved, the purpose of which was to perfect efficient techniques to be utilized in preparing people for some type of directed behaviors, one of which was pornography. He, then, taught these procedures in different areas around the country.

Beginning when I was eleven, in 1951, I was periodically drugged in my sleep, then taken to the basement of our house where I was placed, naked, on a table. I would be surrounded by, approximately, five to eight people¹ and my stepfather would demonstrate different torture techniques which would leave no residual marks as evidence. These included inserting increasingly larger dildos into my rectum for periods of time in order to stretch me without any tears; demonstrations of how a sharp knife pressed on strategic sensitive areas, i.e. nipples, vaginal points, neck points, etc. would reduce resistance-- the manner in which the knife should be held for greatest effectiveness, how to determine the pressure point at which laceration would occur; demonstrations with electroshock pulses of increasing intensity, or a cattle prod inserted into various orifices, to accomplish the same. These "sessions" occurred approximately once every few months until I was fourteen, in 1954. I am able to recount this, even though I was drugged, do to my ability to dissociate. I had always slept with "one eye open", since I never knew when I would be taken out at night to be terrorized. I had learned at an early age that disclosure would prompt a worse situation and that no escape was possible. These "sessions" were only one type of many indoctrination "sessions" which I have remembered.

While I worked very hard in therapy to integrate my experiences and personalities, I was unable to make any permanent progress, a frustration and a puzzle for both my therapist and me. I remained barely functional for a number

of years, battling periodic homicidal and suicidal urges with the help of prescribed tranquilizers and continual therapeutic support. Thus, in April 1991, I checked myself into a hospital in northern Virginia which had developed a specialized unit for the treatment of Dissociative Disorders. Here, I met my second therapist.

He, too, was puzzled by my inability to progress in treatment, since I had begun seventeen years before and had been able to recover my memories without the benefit of hypnosis.

One day, at the end of a session in March 1992, he asked me if the name "Dr. Green" meant anything to me. I answered--no, I didn't think so--, then asked him who Dr. Green was. He said that a colleague had called him that week to report that this doctor's name was coming up, in association with ritual abuse, by survivors in different parts of the country. I, then, heard myself say-- that his name was not really "Green", but Greenberg, Greenbaum or something like that; that I was not sure, but did not think that he was a medical doctor, rather some other type of scientist; that he was a German Jew, who, because he did not look Jewish, passed as a Gentile (my stepfather referred to him as an "Aryan Jew"); that he had learned mind-control techniques in Nazi Germany, then was brought to this country to teach these techniques; that he was the man who taught my stepfather, who, in turn, taught others-- nationally.

I cannot identify "Dr. Green" physically, as I was always either blindfolded or facing into a bright light during indoctrination sessions. "Dr. Green" was present at many of the initial "sessions" referred to above, as well as others at different sites. I do remember that he spoke German (as did my stepfather) and had an accent. I learned that he was actually Jewish (with a number tattooed somewhere on his body) from overhearing a heated conversation between my

stepfather and another man involved, when they discovered this fact.

I do not remember the specifics of any programming. However, I do remember the techniques by which they were instilled: hypnosis, electroshock, sensory deprivation (by isolation- in closets, in underground dirt "rooms", in "graves", under water, etc); death threats to self, others and animals; use of drugs (i.e. varying doses of sodium penythol, peyote or other hallucinogenic drugs, some drug which was an intense sexual stimulant); torture by any and all means imaginable; promises of organizational promotion, success and security; seduction and blackmail. The physical and psychological trauma would produce dissociation, at which point specific indoctrination and programmed responses would be introduced, i.e. *alters* which performed specific duties or responded to particular cues. At the same time, "natural" alters would form as isolated parts of the original personality in response to the trauma. If one was not aware of *created alters*, one could not address them.

After our initial discussion regarding "Dr. Green", my therapist informed me that specific programs had been instilled in MPD systems as a means of mind-control. In July 1992, I began "Deprogramming Treatment" with Dr. Boyd. As a result, I have been able to terminate therapy and am now free from any need of medication. I do, however, live with some residual fear. It is my fervant hope that this Commission will be able to contribute some understanding of the above circumstances.

Dear Commissioners:

This letter is being written and forwarded to your committee through the office of Dr. John Boyd. I am most willing to express to the Commission my involvement, memories and "experiences" of the man I came to know as *Dr. Green*. I believe appropriate to advise you that Dr. Boyd is not my personal therapist, but I am requesting, at this point, that any information I am willing to share be communicated through Dr. Boyd for personal reasons.

As a ritual abuse survivor, much of my recovery has been contingent upon my willingness to re-examine my childhood. I believe that a tenacious will and a basic emotional stability has helped me to perceive more clearly, and even to understand the horrifying abuses to which I was subjected. Painful as the experiences of my past have been, it is through them that I have learned why I have become who I am. Unfortunately, the abuses perpetrated against me have robbed me of much of who I was, and perhaps...who I might have been.

My parents are of well-educated, economically and socially well-established New Jersey families. My father has been prominent in state politics, Masonic organizations and statewide business ventures. My mother is an accomplished artist, and businesswoman in her own right. My parents, who are

still living, were my initial abusers, but much of my abuse was in the form of mind-control techniques and radical behavioral experimentation.

I remember, when I was about four or five, a man came to our house for dinner. He was introduced as Dr. Green, and saw him many times after that evening, both at our house and at another location to which we traveled. Dr. Green was very reserved, yet very polite, but formal. He always seemed to stand very straight, and his movements appeared to be very purposeful, almost military-like. I remember being told that he was an important person, and somehow it was very important to my parents that I behaved well in his company. His bearing and presence made an immediate impression on me, and I vividly remember that he seemed to have foreign characteristics to his speech. This recollection was emphasized by the memory that one time I made him angry, and he spoke in a language that I did not understand, I somehow think it might have been German.

My parents were involved in an ideologically unique, intergenerational sect, and a part of the activity of the sect involved the abuse of others, generally children. It was deemed necessary to methodically control members behaviors and thought processes to fully participate in the cultic goals. Certain of the children were selected, those considered to be the *best and the brightest*, for future leadership within the organization. At about the age of four or five (1949-1950), I was selected for future leadership, and was thus trained by Dr. Green.

As a result of the extreme abuse, I was taught, and learned well, how to dissociate; thus creating alters (or sub-persona) to accomplish certain deeds or tasks for myself and others. The techniques of dissociation, and the creation of alters were purposefully taught to me by and with the frequent use of various drugs ("truth" serum and what were called "dream drugs", which I now believe to be hallucinatories of some kind) and sensory deprivations. The methods of mind-control, for which I became a subject, were actuated by Dr. Green and an accomplice friend of his, another doctor.

I understand that the creation, or *programming*, of specific alters was a part of the abuse plan to allow me to behave in certain ways; and while my learned dissociation may have saved my life then, I believe that there have been times that these created "toxic alters" might have allowed, or even encouraged my demise. I also know that the creation of alters took place over a long period of time and many abuses. I know now too that the creation or evolution of these alters covers a period of time of approximately *nine* years. I also realize that the manipulation of my mind was a planned, organized and purposeful action carried out by a skilled man whose eyes demanded my concentration and obedient response.

Initially, I remember that I was put in a very dark, damp, basement closet-like place (I think an herb collar) by myself, with no light for a long period of time, only to be *rescued* by the doctor, who I was told I must trust. I came to depend upon him and believed that he was the only person that could save me. I learned to trust and depend upon his every word. I later came to accept that any unwillingness on my part to obey, would result in my incarceration either in the "herb collar" or in some dark, cold place (once it was in some kind of cave, another time in a dirt hole in a barn floor with a trap door).


Sometimes, especially when I had to memorize something, they used bright lights, of different colors. At times the lights would flash very rapidly, sometimes more slowly. Frequently the light effect was enhanced with the use of drugs. When I successfully related to my inquisitors the appropriate answers to their questions, or responded with the ideal feedback, the lights would be discontinued. Then there were times that only one light was used, a very bright, very large light that stayed on during our entire "session". It was during this time that I learned to focus closely on him.

... only his eyes, with an aura around the dark outline of his body.

There have been many times that I have tried to dispel these memories as childhood fantasies, but they do not go away. Even after I have remembered them, the horrors do not subside and the memories do not fade. It has been some time now, yet I still remember people (Dr. Green and others), places (traveling at night, almost always at night, to a place near some body of water, for training), and the training itself (the memorization of certain words and symbols, and the creation of other persons who could be "called out" by the use of specific words for some potential task, or to protect that training and programmed behavior desired by the creators).

The memories are real, horrible and incredulous as they may sound. They are the emotionally painful bruises that I carry daily. They are a reality of scientific experimentation gone too far, by demented people who believe that people can be sacrificed for research and children will not remember; or perhaps the expectation or hope was that children would remember, and be called back at some future time to accomplish some unknown "task".

I am a 36 year old white male married with three children. At the age of 30, I went into a spiraling depression with suicidal tendencies. At the age of 31, I was hospitalized and released in about four weeks. I was on antidepressants and in therapy with a psychiatrist. I went to work and things went well for about six months, and then things started happening all over again. I was suffering from depression, cutting myself, domestic violence, anger, and traffic violations. I was accused of embezzlement, lying and stealing. I remembered none of these things, but there was evidence, so I took the blame. I left home intending to kill myself. If it had not been for my wife, I would have. I was hospitalized again, six weeks this time. I was scared to tell the doctors I didn't remember the things I was accused of. I was looking at jail. My wife and her family managed to pay off my embezzlement and make deals with the law. In the hospital, I met a patient that gave me Dr. John D. Boyd's name. She thought he might could help me.

Dr. Boyd did some tests on me, and he said that I was highly dissociative. Over the next few weeks, he gave me the diagnosis of MULTIPLE PERSONALITY DISORDER.

PERSONALITY DISORDER. I was aware of nine personalities at that time. Memories were coming back to me in flashes and dreams. At times I would just keep seeing the same picture over and over in my mind. I would draw them and give them to Dr. Boyd. Sometimes these pictures made no sense whatsoever, but in time they did. These memories were so horrible that most of the time I couldn't believe them. I was seeing Dr. Boyd twice a week just to survive and understand what was happening. After six months, I checked myself into a hospital for MPD. My anger was so out-of-control that I was in fear of hurting my wife and children. I was there for three weeks and went back home. I still saw Dr. Boyd twice a week for the next one and a half years, and even now, still see him once a week.

I have remembered many abuses by my parents and brother. The worst thing my parents did was to send me to live with my uncle on a tobacco farm during the summers. My uncle was a member of a religious cult with an evil ideology. In the name of his religion, I was tortured in many ways. He would frequently take me to a big "church" in Greensboro, NC. There I was meticulously tortured in order to split my mind and control me. I met a man there by the name of DR. GREEN. This man and others strapped me to a metal table, electrodes were placed on my temples, chest, and ankles. I was shocked at intermittent intervals while strobe lights were being flashed and instructions were being yelled at me about my internal workings and my future. This began when I was eight years old. There were times they would wrap me up like a mummy in ice cold sheets, pouring cold water over me, yelling and screaming things at me while they were sticking me with needles. I was drugged at time, and they made me believe I did things that I now know I didn't do, but as a child I was sure I had done.

~~.....~~ They would keep me awake hours on end with no food or water. They enjoyed seeing children beg for food and cry to go to sleep. During times of torture they had tape recorded messages playing, videos playing, all with instructions for me to follow. I was to lead a normal life and at the age of 33 return ~~.....~~. The last few times I was taken to Greensboro I was introduced to a DR. LOWENSTEIN and DR ROSENBERG. I was strapped in a chair, and the electrodes were put on me. They would call out alters, and if they didn't answer, I would get shocked. Personalities would be called forth to recall their programming (instructions) in explicit detail, and any wrong answers always ended in being shocked. These are only a part of my memories. My life was almost ruined by these people. Reliving these memories was the hardest thing I've ever had to do.

At that time, I had over 400 alters. Now, Dr. Boyd and I have integrated all but about 30. I live a fairly normal life with my wife and children. I've been lucky they stuck by me. I am in a community college now, and I have two more semesters to complete before I graduate. I have done well with a 3.8 GPA.

I can still recall these memories, and I will assure you that they are not hallucinations or dreams. The abuse I suffered under these people

was very systematic and deliberate in order to split my mind creating alter personalities to achieve total mind control over me. There was an elaborate setup used to torture us. It reminds me of an operating room.

My mother and brother have confirmed some of my memories, and I have many body scars and conditions that coincide with my memories. My wife and I secretly visited my uncle's farm to confirm my memories of the placement of barns, smokehouses, cabins, ponds, etc. where abuse took place. My map was almost identical to their placement and it has been almost 20 years since I've seen it. I wrote a letter to my uncle denouncing what he did to me and tell him that I no longer wanted anything to do with his religion. I have received a couple of messages from my uncle directly and about four messages indirectly from other family members.

My brother, now at the age of 41, has begun having memories for the past year. I am certain that he has suffered from the same abuse I did. He has just now, as of December 1994 started receiving therapy.

Thank you for listening to my story, and I hope that you can put some conclusion to this abuse that many of us suffer from.

**TO THE PRESIDENTIAL COMMISSION
ON RADIATION EXPERIMENTATION
BY GOVERNMENTAL AGENCIES**

I am a licensed clinical social worker in private practice in New Mexico and I have been treating victims of government mind control programming for over five years. In that time period, I have come in contact, through my own practice and in consultation with other therapists and facilities in my community, with up to 100 individuals (conservative estimate) with evidence of mind control programming. I have worked directly with four psychiatric hospitals and treatment centers, two with programs for dissociative disorders, and up to two or three dozen local therapists, giving me some sense of the overall survivor community here. This community is appallingly large for such a small state, perhaps due the considerable military presence here.

In my own practice, I have treated or consulted with up to forty individuals with histories and symptoms typical of mind control victims. Of the fifteen individuals who have been in therapy with me over the past five and a half years for a minimum of two to four years each, 6 have clear and explicit recall of mind control programming which took place on military bases and in government labs; 6 others had alter personalities who reported memories of same. (Because the programmers dissociate these individuals, recall typically is a progressive process with one individual recalling the next day.) Of the six

part of the person remembering before the rest does.) Of the six with clear recall, one also received radiation. Another is herself a trained programmer of children who has detailed information of how some of the programming is done.

All of my patients report receiving programming from early childhood. Frequently a family member was involved in the military or worked for a government laboratory. Additionally, I have had a sixth patient who was a licensed therapist herself and left the state to work with another therapist with expertise in this area when she realized she had been unconsciously involved with government mind control effecting her own patients.

Patients have reported being experimented upon in laboratories and on military bases and university campuses here in New Mexico (Sandia Labs - numerous reports, Kirtland Air Force Base, Los Alamos Labs, Roswell - numerous reports, White Sands Missile Base, University of New Mexico laboratories), in Illinois (Chicago, Argon Labs), in Colorado (Colorado Springs - numerous reports), Texas (Amarillo and other numerous locations near military bases), California (Edwards Air Force Base, Berkeley Labs, and other locations.) Much of the programming reported has gone on since the 1960's (some as early as the 40's and 50's) up to and including the present. Most of my current patients continue to be programmed even while they are in treatment in what appears to be efforts to sabotage the treatment process (especially recall) and redissociate the patient. Underground facilities where programming is done have been reported at Sandia Labs by four patients and in Colorado Springs (NORAD) by two patients, while numerous patients have referred to Colorado

Springs generally.

Current programming of my patients appears to be ongoing at Sandia Labs (bunkers), Kirtland Airforce Base, Roswell, N.M. Other locations may be involved as well.

All programming is based on creating dissociated ego states in the individual and is diverse and particularized to the individual. Certain types of base programs, as well as secondary programs, exist which can be identified in most individuals even though the details of the programs vary.

Universally, patients report the following mind control experiences from infancy (involvement of the immediate family is commonly the case):

Use of drugs, electroshock, sexual molestation and rape, various physical tortures (drowning and resuscitation, burning, starvation, physical isolation, physical abuse of various types). Also used are computer screens, flotation tanks, isolation booths, gurneys, IV's, restraints, video screens, audio technology, virtual reality, etc.

All who have been involved in mind control experimentation and programming in government labs or on military bases are convinced of government involvement. Government agencies referred to are the CIA, Department of Defense, NASA among others. These individuals are convinced by their programmers they risk death or harm to their loved ones if they talk and that there is nowhere to turn for help in our society. They are subjected to programming to doubt their own reality and told no one will ever believe them. Care is taken to protect the anonymity of the

programmers. Multiple programmers are used, usually dressed alike with similar haircuts, etc. Often a therapist look-alike is evoked in the laboratory setting to further confuse the victim, although most survivors can usually tell the difference afterwards if not during the actual programming session. The programmers appear to have achieved a level of considerable sophistication in their technology and practice.

While it is not possible at this time to verify all of the accounts that we receive of mind control tortures, there is enough underlying consistency to these reports from unconnected sources to merit our investigation of them. It is imperative that a Presidential Commission be appointed to investigate the potential for crimes against American citizens who, if they are in fact being tortured and abused, are being ruthlessly exploited and who have no recourse for protection or validation.

I have first hand knowledge of the radiation experiments and other experiments conducted on human subjects, without informed consent, by U. S. government officials and at U. S. government facilities (as well as other facilities) during the 1950's and 1960's.

The experiments on me began when I was about three years old and the experiments continued for about a twenty year period. The experiments and related activities included the following:

- o use of radiation on my body and inserting radioactive material into me;
- o administration of various mind-altering drugs including LSD;
- o physical torture including 1) pulling my knees out of their sockets repeatedly; and 2) insertion of various painful objects in various parts of my body;
- o sexual experiments, rituals and torture of many kinds;
- o mind control experiments utilizing extensive electroshock, hypnosis and drug administration combined with various kinds

of intense mind programming;

- o administration of blood products and other chemicals through transfusions and other modes of delivery; and
- o child pornography photographing of me (alone and with others).

This experimentation was extensive and the experiments occurred repeatedly and frequently. The experiments were often accompanied by terrible death threats and torture to convince me not to tell anyone what was going on. One of the most extensive means of torture and mind control, which began at an early age and continued throughout all the years, was the use of snakes to terrify me.

The group involved in these experiments was primarily composed of people in U. S. intelligence agencies and various branches of the military, although some civilian government officials were also involved. Many of the governmental officials were in high level positions. Some activities related to the experiments involved private citizens. My own father was involved with Naval Intelligence in World War II and that was mainly how my family and I were linked to the intelligence and military officials that were involved for so many years in the radiation and mind control experiments conducted in this country.

The locale for the experimentation done on me from 1947 - 1962 included principally Utah, Nevada, Arizona and California, but some experiments occurred in other Western states. Most experiments occurred in U. S. government facilities or on U. S. property.

Starting in 1962, the nightmare of experiments and related activities continued for me for several more years when I was relocated to the Washington, D.C. area. Again, the experimentation, torture and abuse occurred in many U. S. government facilities including in: 1) high level intelligence and military facilities in Northern Virginia; 2) CIA safe houses in the area; 3) private homes of some government officials in the metropolitan area including Alexandria, Falls Church and Arlington; 4) Ft. Detrick in Frederick, Maryland; and 5) in the Fort Meade/NSA area in Maryland.

There are a number of names of government officials who were involved in the radiation and mind control experiments and related activities that I can supply, but among the key individuals were Dr. Sidney Gottlieb of the CIA and Dr. White, Dr. Green and Dr. Hamilton who were working for Gottlieb in some capacity. There was a Nazi doctor who played a key role in some of the physical and other sadistic experiments done to me.

There is more information that I can supply about some of the government and non-government facilities that were used. For example, I have drawings of the layouts of some of the property and places where products of some of the experiments were disposed of. In order to protect myself, I have placed this material, along with other more extensive information, in a safe.

Other more extensive documentation, in several safe and secure places.

The personal consequences of the nightmare of these experiments, torture and abuse have been devastating - physically, mentally, emotionally and spiritually. I had significant physical health problems as a child and even more significant medical problems for over twenty years of my adult life. I have had many years of psychotherapy to cope with the effects of these radiation and mind control experiments and my professional career and my relationships have suffered as well. But perhaps the greatest burden for me now has been the emotional and physical pain caused by these experiments, combined with the knowledge that my country's government allowed such experiments and other activities to take place - that there was insufficient oversight to curb the excesses and atrocities that occurred.

I believe that it is only with the full revelation of what occurred in these experiments that the safeguards that are supposed to operate in our democracy can be put in place so as to avoid such tragedies in the future. Despite all that has happened to me, I believe in the wisdom of our democracy, but I know better than most citizens of the terrible excesses of governmental power, especially when secrecy and national security are used by the government as a cover for human evil and an attitude that the ends justify the means.

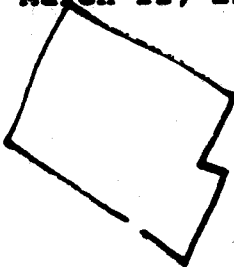

The Presidential Committee on Radiation

Dear Sirs:

This is my personal witness of victimization by radiation and a progression of mind control techniques. The following knowledge has come to me outside the benefit of a therapeutic relationship. I look forward to being able to support my personal truth with published material. It is written anonymously in accordance with my understanding of the spirit of its presentation. I have attempted to outline extensively documented recall contained in audiotaped and written material shared with both law enforcement and therapeutic communities since 1988. Names of people mentioned here are those I commonly knew them by and may not represent their legal identities. I have drawn many of them and would welcome the opportunity to view photographs with the purpose of identifying them. Names of places mentioned were overheard in conversation at times when the person responsible for me seemed to think I was too drugged or dissociated to remember. I have drawn some of these places and I would welcome the opportunity to validate my memories by visiting them.

I was born in 1944 into a family which had consistently had

generations. My legal father was in the Air Force. A young physician I knew as Dr. Korim (spelling?) instructed my mother in the beginning of mind control techniques at the age of 6 months until my middle teens. A friend of my mother's with Navy survival training named Joe Montalbueno (spelling?) assisted by a boyhood friend of my father's named Henry Blessing have continued to carry out mind control techniques on me all of my life.

At the age of 18 months I met a person I knew as Herr Doctor. My mother spoke to him in German. I was taken to New York City where I was subjected to what I believe to be radiation to my head. The machines resembled older styled X-Ray units and produced the generator whirring sound peculiar to them. I was also given electric shock.

At two I was enrolled in a class of 10 other girls who were being taught dissociative techniques by Prune, a school in New Britain. The rest of the group seemed to range in age to 10 years old. I was sexually abused routinely after class to curb my rebellious nature. My mother broke my left arm across the top when I was 3 so that I would not use my left hand. They used water, lights, hypnosis, sexual abuse, electric shock to train me to pass messages from person to person. There were often men in military uniforms who participated in this training.

I learned how to handle weapons, particularly how an ice pick left as neat hole. A hole that allowed so little blood to escape that

the victim could remain in public view for hours before they would be discovered to not be napping. With each stage of the training I split inside my mind, more and more. Joe tested my reaction to centrifugal force and what restraints I could escape from in laboratories in the Quantico, VA area. I was taken on planes to Germany and Egypt to assist Joe with arson, to Israel alone with messages, to Mexico for terrorist activities. I remember a small laboratory in a partially exposed basement of a large building I visited many times, starting at age 4, south of Washington, D.C. I was taken to Connecticut to a building connected with the Compensating Reservoir in Barkhamsted. Some of my training took place at a camp in Amston, CT. At the age of 14, I was drugged and woke up on a stretcher where I heard men outside my door discussing how they had "gotten me past the guards at Langley" that night.

At the age of 15 Joe introduced me to an elderly man he referred to as the "Senator". At the Mayflower Hotel in Washington, D.C., the portly gentleman was brought to a room adjoining ours, Our closet space was filled with photographic equipment viewing the senator scene. I refused to participate. I was severely punished.

Joe has continued to influence my life and has tried to intimidate me to this day. He has interfered with my relationship with my husband and my children. He still tries to get me to do jobs for him as I had been trained to do so long ago.

I thank you for listening to this witness. Because of my extensive exposure to mind control techniques, the darkness of my relationship with Joe and his associates has touched my husband, my children, other family members, employers and friends. It threatens now to touch a third generation! Maybe my eventual freedom and complete healing will forever remain beyond my reach. With every breath I take, I pray that it is not so. I am vulnerable to anyone who knows my cues and triggers better than I do. I am vulnerable to anyone who is threatened by what may still lay buried deep in my memory. There is no law prohibiting anyone from attempting to kill me by activating my own mind against me.

I physically struggle with the accumulated affects of my accumulated trauma daily. Ligaments were stretched when vertebra, hip, elbow and knee joints were dislocated. Nerves were damaged by electrical impact. Muscles contract trying to adapt to compensating positional changes. I have no idea what possible consequences my future holds for me due to my exposure to radiation. Our system of justice does not protect me from the people who have attempted to steal my entire life.

The group of my personal perpetrators is relatively small. But, I wonder what national policy lays behind this type of child abuse and why? I wonder who sanctioned and developed it. I wonder who attempts to conceal the truth of its existence and extent from the American people now?

I request from the members of the committee a thoroughly complete

investigation of this type of severe child abuse. You must prevent future generations from being victimized by those who are elected and chosen to protect them. I believe this is a matter of utmost importance and demands the full resources of your office.

The statements herein contained are allegations asserted to have been committed by the Central Intelligence Agency of the United States of America from January 1964 through July 1976. This is a first-hand account written by the recipient of these actions, who will pseudonymically be referred to as "Amy" to reduce the risk of retribution from the actors involved.

I (Amy) wish only to document these happenings, and have no intention of personally pursuing these matters legally. The following reflects events as I witnessed them, and is in no way, an attempt to slander any representative individual or group of any government or organization.

PROGRAMMING

I was three years and four months (3yrs4mo) old when I was taken to what would later become known to me as the "Station." Located underground near Amarillo, Texas, the Station was a large, sterile facility I was taken to many times throughout the course of my training. I am unable to identify the exact location, as I was placed in a burlap sack, tucked in the back floorboard of my parents' 1957 Comet, and driven to a location known only to them to be turned over to my "teachers," (government agents who programmed me). Most often, these trips occurred between 3:00 -

4:00 am, and I was not allowed to see anything until the "teachers" had me in the Station. I was given a mild, oral short-acting, sedative to assist my parents in delivering me quietly.

For the first six (6) months, I was "taught my lessons" in a closet-like space painted white. Its dimensions were approximately 3'X 3'X 10'. There was a door making one panel of the closet where myself and my "teachers" entered and exited. The door was knobbed only on the outside so that once inside, I had no way of letting myself out. The panel across from the door had a small square cut out and paned approximately 5' up where light from a photo projector shown through. There were also holes in the same panel, where later, electroshock implements would be wired through.

During each programming session, I was placed in the closet, facing the door panel. I was completely naked. After a period of about ten (10) minutes of total darkness, the light projector would shine through the small opening, making a large light square on the door panel. Elementary, cut-out figures of bunnies, kittens, squares, circles, and boxes were attached to wooden tongue depressors and placed in front of the projector, creating a large shadow of themselves on the door panel. Some of these figures were constructed of transparent materials, making an outlined shadow, while others were made out of black materials (construction paper), forming a completely filled shadow on the panel. The temperature of the closet was kept cool enough to just be uncomfortable to bare skin. A women's voice accompanied the shadow figures. Most of what the woman said was about good and bad, with "good" associated with the black figures, and "bad"

coupled with the opaque shadows (exactly opposite of Western culture's binary pairings). Many states of deprivation were used in addition to the visual stimulation like hunger, cold, heat, too much auditory stimuli, too little auditory stimuli, etc. The woman referred to me as "it." (ie. "Does it know what this is?" "Does it want out of the box?"). I was not allowed to move onto other programming until I created a dissociative ego state separate from the rest of my psyche. They gave the ego state a name of their choosing and called me that name when they wanted her to present.

In addition to the Station, I was taken by my mother to an ophthalmologist's office in the city of Amarillo a number of times. I was five years (5 yrs.) old the first time I can recall (although my mother reports that I was "treated" by this doctor from age two). My mother turned me over to the "nurse" calling patients back. The "nurse" took me to a small ophthalmology office located right in the center of the building, with an administrative office off to the right of the room. The "nurse" sat me in a chair in the administrative office, across from an empty physician's desk. After about ten (10) minutes, a large-framed, middle-aged, red-haired woman in a green two-piece suite and light stockings entered the office, introduced herself as "Mrs. Simms," and took a seat opposite me. She was smiling and calling me yet another name. She explained that we would be doing a number of "fun" things together throughout the course of

the day. She praised me for being well-mannered, and led me to a black examination chair in the exam room. The "nurse" administered stinging eye drops in each of my eyes and the room went completely black. I heard the "nurse" call my new name and asked if I was "here yet." She then projected english words and letters on the wall across from me. My eyes were out of focus. The "nurse" became more and more irritated with my silence and told me she was going to get the doctor to make me speak. "Mrs. Simms" came in was not friendly this time. For what seemed like many hours, I was forced to repeat letter and number sequences that had no meaning to me. Most of the sequences were nonsense pairs, or things that are not typically grouped together. Some of the letters were upside-down. There was a break in the day, when I was given back to my mother for a short period of time, but none of my physical needs were attended to like my need for food, liquid, or to be taken to the bathroom. We had come in the morning, and were not released until the sun was going down. There were about ten (10) days intermittently spent this way over the next year, and an additional ten (10) days at age 11.

When I turned eight years (8 yrs) old, the torture aspect of the programming became much worse. I was accompanied by "teachers" at the Station to a tank holding a large amount of water and between one and three dolphins. All the "teachers" were dressed exactly the same: plain grey suite, white long-sleeved shirt, black leather shoes, black plastic-rimmed glasses, gold-colored watchband, and crew haircut. They were indistinguishable from one another. Very few women were present, but the ones I saw wore grey, two-pieced suiteskirts with light stockings. Their

hair was pinned in a bun and they wore black, low-heeled shoes. Again, I was naked when all the "teachers" in the room were clothed. I was told that I was going to learn to "speak to the dolphins." A number of these sessions were used to familiarize me with the dolphins and the dolphins with me. I was given a set of headphones and was able to hear the sounds the dolphins were making underwater. I was instructed to imitate those sounds. I remained silent. When I was noncompliant, I was placed in the closet described at the first of this section and electrically shocked at terminal points on my temples, wrists, thighs, and ankles. Before each shock, I heard a woman's voice say, "We are very unhappy with you." My eyes and teeth hurt from the electricity. I was taken out of the closet and back to the water tank over and over, but I refused to imitate the dolphins. By this time, I was being used to program younger children in the same manner as I had been programmed at the beginning. I was angry that I was being used for the "teachers'" means, and not obeying was the only way I could think to protest. I was told if I continued to refuse, my little sister would be slain in front of me, that some of my programming subjects would be killed, that I would be forced to kill my sister or my subjects, etc. I was drown in the tank on three (3) occasions, and resuscitated in a pool of water and vomit. I was forced to eat a fetal puppy, hind legs first. I became more and more resistant. The final act of torture occurred when I was eight years, 2 months old.

electroshocked in the closet and taken to the tank. One of the teachers was holding a three month old baby girl by the back of the neck. She was making no noise. There was a man in a diving suit in the tank with one of the dolphins. He was holding a large, serrated knife in his hand. The teacher on the platform told me I was to decide which of these, the baby or the dolphin, would live. After remaining silent for four or five minutes, I softly said, "Save the baby." The diver stabbed the dolphin in the middle of its chest and made a slit down the length of its body. Blood and entrails flooded the water. I was pushed into the water from behind. When I came up for air, I saw that the platform teacher had dropped the baby in the water anyway and she was floating face-down on the surface, dead.

I lost consciousness, and woke up nine (9) days later in a free-standing surgical center in Amarillo. The center was abandoned and silent, except for the sound of the respirator I was connected to. A doctor came in several hours later to disconnect the respirator. I was taken back to my parents, residing in a small town in the Texas Panhandle. Not a word was spoken of the event, but when I returned to my third grade class after Christmas break 1968, I was unable to recall anything I had learned in school previously (multiplication tables, social studies lessons, etc.). I was not taken to the Station for a number of months after the coma.

At some point between ages 9 and 11, instructions were coupled with a series of chess moves. I made many flights to Europe (Germany and England mostly) for "finishing," where I was versed in political issues (i.e. the Cuban Missile Crisis), classic

literary works, and other matters of world interest. I was instructed (mostly by elderly women) on the differences in types of wine, entrees, clothing, manners, etc. I was taught by younger women how to maneuver sexually to "take a man's mind off anything." After much training, I was used in the United States to assist the C.I.A. in covert operations, mostly as a sexual escort to distract government officials that were later assassinated by other players in the operation. All of these assignments were initiated over the phone by a male voice saying a specific, pre-laid chess move in a certain order, which would bring a dissociated part of me to the forefront for further instructions at a designated meeting place. Each assignment was delivered with the explicit warning that death would be sure should I deviate from the instructions in any way.

In 1976, the government stopped using me. Contact was reestablished in January 1994, when I was placed on "stand-by" status for an assignment in North Vietnam. Details of the job were never relayed to me and I never went to Vietnam. I was abducted from a college campus in New Mexico in August of 1994, and taken to an underground facility I believe now to be associated with a prominent lab. in Albuquerque, New Mexico. I had begun work on a project involving "computer hacking" data off the InterNet of demographic information on elementary school-aged children entered on classroom computers, when I became aware of the dissociated part of me that was participating, and discontinued any activity around that

calls, verbal threats, and was even physically assaulted, for refusing to continue the project. Before each of the three (3) abductions, a stranger would approach me and speak a chess move, altering out a compliant ego state. I would regain consciousness in the surroundings of my own home, unaware that I had been anywhere or done anything. Once I realized what was happening, I refused to go with the abductor the fourth time and have not been to the facility since.

These events have caused a great deal of difficulty for me, and remain a formidable obstacle I face each day. The painful part is that I was harmed by an agency of my own government, in direct violation of rights I am guaranteed as a citizen of the United States. No one in our country should be subject to such mistreatment yet, I believe these activities are still going on today. Any action leading to the protection of our nation's children (and adults) from such damaging abuse is worth the time and money it will cost to carry it out.

Thank you for your consideration of the above. God bless you in the days ahead.

**March 6, 1995 - Testimony for the Presidential Advisory Committee
on Human Radiation Hearing - Dept. of Energy**

My daughter is a survivor of sexual abuse, torture, and mind control. In 1991, she was diagnosed with Multiple Personality Disorder (now called Dissociative Identity Disorder). She has been in recovery for the last four+ years under the competent guidance of a therapist who specializes in treating survivors of sadomasochistic abuse and mind control. Listed below are the techniques she has described as being used to program her like a robot. My feeling is that the purpose of this programming is to create multiple personalities who are programmed like a computer to perform certain tasks on command. The creation of multiple personalities also produces amnesia between the various personalities to enable one personality to emerge and perform a specific "job", then go away and not remember what they did or who forced them to do it. Those "jobs" include child/adult prostitution and child/adult pornography on a local, national, and international level.

February 2, Christmas, Easter, birthdays, and other religious
holidays. For the last 4+ years, we have consistently received hang
up calls around these dates. My daughter has explained that the
number of hang up calls received or the time of the call are codes
for telling her that she needs to contact her master for instructions.

As much as I did not want to believe this had happened to this
innocent child, I could not deny what was before my very eyes. I have been
present in many memory processing sessions and witnessed the body
reacting to remembering the abuse. My daughter would have seizures
while remembering the electroshock. She would have body markings
(bruises, discoloration, hives and redness) and body sensations (vaginal

(bruises, discoloration, rashes and redness), and body sensations (leg and rectal discomfort, feeling too hot, feeling too cold, stomach nausea and discomfort). The screams and cries from the terror she remembers are undeniable. There is no way she could be acting or making this up.

As I learned about the horrible crimes committed against my daughter, I read everything I could find involving the occult, organized criminal activity, brainwashing techniques, and mind control. It was only then that I realized the striking similarities between what my daughter was describing and the mind control research done by the CIA, beginning in the 1950's. I have since learned that the CIA drug and mind control experiments are still going on.

The most compelling evidence I have seen which confirms CIA involvement is what is identified by many victims of mind control as "the black box". My daughter has drawn pictures of herself hooked to wires that lead to a small black box. As I later learned, the black box is a source for the electricity used in electroshock torture. I personally witnessed the dismantling of one of these boxes by an experienced electrician who had basically no knowledge about electroshock torture. It

was his conclusion that these devices were assembled purely for the purpose of sending electricity through wires. These boxes were traced back to the manufacturer, and it was discovered that the only order placed for these boxes came from the CIA.

Then my daughter began revealing some of the people involved, including doctors, neighbors, church officials, and patients with whom she had been hospitalized. Listed below are names and information about some of her perpetrators:

Kathy Schwiderski - My daughter told me on the first or second day upon entering the hospital that there was a woman on the unit who had hurt her. The woman she pointed out to me is Kathy Schwiderski. Kathy has now recanted her stories of abusing her children and others and is suing her former therapists.

L. T. and Lucy Abney - Lucy Abney was admitted as a patient and put on the same unit as my daughter. My daughter was not comfortable around Lucy; and when Lucy's husband, L. T. came to visit, my daughter had to leave the room and was very afraid of him. She now knows that both L. T. and Lucy

abused her. Lucy Abney has recanted her stories of abusing her children and others and is suing her former therapists. I have since learned that a woman named Elizabeth Carlson is a friend of the Abneys, and is involved in bringing a lawsuit against a therapist in Minnesota.

Carol Frost Buis - This woman adopted my daughter as an infant and gave up custody of her at the age of 2 through a divorce. However, Carol still had visitation rights every other weekend. My daughter has told me that Carol took showers with her, had her sleep with her, sexually molested her, threatened her with a knife and a gun, threatened to kill her and/or others, tortured her through electroshock, left her alone for hours or locked her up for hours, prostituted her, and forced her to do things against her will.

Floyd and Mildred Frost - (parents of Carol Frost Buis) My daughter describes being sexually molested and tortured by Floyd, Mildred, and Jody (Carol's brother) with electric shock using wires attached to her ears, nose, teeth, vaginal and rectal areas. She also describes how her grandfather (Floyd) passed her around among his friends for sexual gratification. Then he would take her to Dairy Queen for being such a

"good girl". To this day, she is unable to set foot in a Dairy Queen.

Jack F. and Jill Coogan - On October 5, 1994, Jack Coogan pleaded guilty to tax fraud and was sentenced to 6 months community confinement, a \$15,000 fine, and 500 hours of community service; he owns CISCo (Coogan Industrial Services). My daughter says that Jack Coogan was her master and pimp, a.k.a., "Uncle Jack". The last time she saw the Coogans, my daughter came home from their house (March 13, 1991) and immediately became agitated, distraught, and self-destructive and had to be hospitalized.

Dr. Gary E. Miller - This doctor performed electroshock/LSD torture on my daughter for the purpose of programming her. When her therapist moved her office to a new building and I took my daughter to the new building for the first time, she told me she felt like she had been to that building before. I later discovered that Dr. Miller's office was in the same building as my daughter's therapist.

Dr. George S. Glass - During a hospital stay, my daughter was watching TV and saw an ad by Dr. Glass. She recognized his voice and became very agitated and frightened.

agitated and frightened. She later remembered that he has programmed her. Another patient on the unit with her also had a reaction to the ad.

"Dr. Green" - we have since learned that many of the doctors who tortured and abused my daughter were only known to her as "Dr. Green". Some she has been able to identify, but others are unknown at this time. There is an Dr. L. Wilson Green who was connected to the CIA. She has also remembered that the people who tortured her often wore black vests or coats that look like the kind employees in doctors' offices wear when taking x-rays.

I have researched this complex subject for the last 5 years, and my conclusion is as follows:

There is an internationally organized network of people (probably pedophiles) who systematically torture and program children for the purpose of making money through pornography and prostitution. The system of programming through torture and abuse strongly resembles the techniques used in research by the CIA. In 1992, accused parents of an adult survivor formed a group called the False Memory Syndrome Foundation. These people made up the term "false memory syndrome" and have been discrediting survivors and therapists all over the country, claiming that therapists plant ideas of abuse in their patients.

Interesting points re: False Memory Syndrome Foundation

- a number of members of the Advisory Board for False Memory Syndrome Foundation have CIA background, two of whom are Louis Jolyon West and Martin Orme
- many FMSF Board members have extensive military background and/or University connections where the CIA has funded

drug and mind control experiments
-FMSF can now be linked to many malpractice lawsuits against
therapists across the country
-so-called "experts" who are proponents of "false memory
syndrome" are blitzing the media with propoganda and have no
clinical experience with survivors of this type of abuse

The above information barely scratches the surface of this complex system of crimes against children and other criminal activity. I believe that my daughter has been used as a guinea pig for experiments and victimized into being used by criminals and pedophiles. I can provide you with much greater detail and many more names, locations and connections. I am prepared to make a statement to the appropriate officials regarding this information.

Affidavit of Marilyn Matson

I, Marilyn Matson would like to swear to and state the following:

1. I was physically abused and my mind programmed at V.A. hospitals during the years 1950 to 1954. I was between the ages of 11 - 14 at the time. My father, Ralph A. Matson was a Major or Lt. Colonel in the U. S. Army. I specifically remember being abused in the Salt Lake City, Utah, V.A. Hospital at Fort Douglas. It was the old V.A. Hospital.

The methods used to program my mind were pain and torture, repetitive sounds in my ears, flashing lights, sleep deprivation drugs etc. My father was often present during these sessions. The torture and programing was done by doctors and/or orderlies. Sometimes there were other men in business suits present. The names Green Room, Greenbaum or Greentree are associated with these sessions.

I remember being taken to other V.A. hospitals around the country

By my father when he went to "camp". I am not sure of their localities. The program methods used were similar.

2. Between 1975 and 1980 I was in the care of a psychiatrist Dr. Tom Fox MD, in Logan, Utah. He continued to program, sexually and physically abuse me in his private office. He used his private office as well as the old Logan Hospital and other localities. At times he was joined by a Dr. Black from Southern Utah. The last incident I recall was in 1985 at St. Marks Hospital in Salt Lake City, Utah, where I had been hospitalized for depression and ECT treatments. Although he was not my attending physician, Dr. Black visited me several times to check if the mind programing was still intact.

3. I have had a 30 year history of mental illness with various diagnoses. Since my memories have emerged and I have received proper treatment, I am finally getting well.

UMBRELLA

(1950's)

(This was the first project name
under which all of the other projects fell.
It came under the Office of Scientific Intelligence)

BLUEBIRD

(early to middle 1950"s)

(This was a CIA project, but the name had
to be changed because the Navy was using the
name for another project)

ARTICHOKE

(1950's)

(They used everything in this project.
It is likely to contain radiation files)

OPERATION SECRET

(late 1950's)

(This was a CIA project funded by NIH.
Included in this project was a project named
SENSITIVE RESEARCH)

MKULTRA

(This is the best known mind control project.
In an effort to continue funding,
they repeatedly split the names
as follows:

MKDELTA

(Operation side, brain mapping, psychological
research)

OFTEN/CHICKWIT

(These experiments took place at Edgewood
at Fort Dietrich)

(OFTEN covered research in U.S.
from mid 1960's to mid 1970's,

CHICKWIT covered research outside of the U.S.)

THIRD CHANCE

(This was the last chance to prove that
mind control methods worked)

The Human Ecology Society was formed after funding ran out for MKULTRA. It was a front to gain funding from private funding to continue the research projects. This name will probably not appear in any CIA references. The CIA projects under this were as follows:

CHATTER

(This continued to the late 1970's
and included drug experiments, especially
LSD)

MKSEARCH

(This is where the main radiation and
germ warfare experiments were conducted)

The Human Ecology Society later became Experimental Research and
then Association for Psychological Assessment.

Claudia says that the main places to look for radiation files would
be under the Science and Technology Department of the CIA,
particularly under ORD, Office of Research and Development. The
Scientific Engineering Institute provided private funding to the
CIA for this. She also says that there may be something under the
Technical Services Division (TSD) which is included in Clandestine
Services, the "Dirty Tricks Department". Also to look in TSS,
Technical Science Services which came out of TSD for radiation
files.

Other CIA projects were as follows:

MKNAOMI

(includes germ warfare and some radiation files)

MKDELTA

(Includes mind control, drugs and radiation)

TRIMS

(This is a place and a project name in the Air Force in Texas. Radiation research was carried out here which related to work at the Edgewood Chemical and Radiological Laboratory of the Army Chemical Center at Fort Dietrich, which is where Dr. Greene was apparently the Scientific Director under the Army)

Other important projects:

GREENHOUSE

(1940's)

(This project covered bringing Nazi scientists into the U.S.)

Claudia says that when the Rockefeller Commission asked Frank Church to determine if radiation should be investigated during the Rockefeller Commission, he was invited to attend a demonstration of the affects of mind control and radiation. She says that he was blackmailed and paid off to say that there was nothing wrong with what they were doing. He got Lashbrook, Dr. Charles Geshecker and Colonel Monroe to testify that the radiation experiments were not

a problem for people. All of these people were involved in the
mind control research.
